Northshore School District administers Smarter Balanced Assessments (SBA) in English/Language Arts (ELA) and math in grades 3-8, SBA ELA in grade 10 and SBA Math in grade 11; Measurements of Student Progress (MSP) in Science for grades 5 and 8; End-of-Course (EOC) in math for grades 9 and 10; and EOC in Biology in grade 10 to students annually in compliance with state and federal laws.

School Improvement Plan

At Cottage Lake, we are committed to increasing and deepening student understanding and achievement. We utilize research-based instructional strategies and usage of quality teaching materials. Cottage Lake's School Improvement Plan is closely aligned with Northshore School Board's adopted goals.

As the work of our building builds from one year to another, our School Improvement Goals included:

- Increase the percentage of students meeting grade level standards in reading accuracy and comprehension
- Increase the percentage of students meeting standard in math by the end of 5th grade





School Improvement Plan cont.

In order to meet these goals, the staff at Cottage Lake participated in the following:

- Provided opportunities for professional development around reading progressions
- Increased knowledge about differentiation in reading and math
- Collaborated with colleagues within grade levels
- Administered reading and math assessments throughout the year to track progress and identify learning needs.
- Implemented small groups to meet student's needs

Throughout the process of collecting data, setting and prioritizing goals and selecting effective practices, staff members worked to enable all students to achieve at high levels in all academic areas. Continuous evaluation of the current School Improvement Plan provided a means to assess strengths as well as areas of need and to help guide our future decisions.

Facility Information

Cottage Lake Elementary School was built in 1958 on 10 acres. It is a beautiful school community, situated just off Avondale Road, and is surrounded by mature grounds that give a feel of a quiet, park-like setting.

Phase One of the building and site modernization was completed in 1999 and included a new gymnasium, administration building, four new classrooms and a multi-purpose room that serves as a cafeteria. Phase Two, completed in 2005, included 16 classrooms, a library and computer lab. Cottage Lake embraced the sustainable design features of natural ventilation, natural lighting and a low impact design for storm water infiltration called rain gardens.
