Northshore School District administers Smarter Balanced Assessments (SBA) in English/Language Arts (ELA) and math in grades 3-8, SBA ELA in grade 10 and SBA Math in grade 11; Measurements of Student Progress (MSP) in Science for grades 5 and 8; End-of-Course (EOC) in math for grades 9 and 10; and EOC in Biology in grade 10 to students annually in compliance with state and federal laws.

School Improvement Plan

Our School Improvement Plan focused on supporting the growth of each student in the area of reading. This plan is a living document closely aligned to the district goals.

Moorlands staff participated in professional development to enhance their skills in the use of effective instructional practices and for the implementation of the district reading curriculum. Certificated staff continued to learn about Common Core State Standards and participated in work around developing strong collaborative practices focused on data-driven student learning. Throughout the process of collecting data, analyzing school portfolios, setting and prioritizing goals, and selecting effective practices, staff worked to empower all students to achieve at higher levels in all academic disciplines including reading. We consider this work part of our professional responsibility and work continuously towards improving our practice. Ongoing evaluation of the School Improvement Plan provided a means to assess strengths as well as areas of need and helps guide our future decisions.

Moorlands continued to use programs that have been critical in reaching the whole child, including character education.

- 6. Repeated steps and revised SIP, if needed.

Facilities

Moorlands Elementary School opened its doors to students in the fall of 1962 and was remodeled in 1992. Our school is situated in a neighborhood setting with separation of buildings, providing landscaped areas and play space. We have a community park adjacent to our playground for student use during the day. During the 2014 school year, PTA made a commitment to campus beautification projects. We want our campus to be an inviting representation of our amazing community!

The school gym and fields are used extensively in the evenings by the community and for special school events.
