Our School Action Plan included the following:

- Provided opportunities for staff professional development: equity, curriculum alignment, differentiation practices in literacy, Positive Behavior Supports and Intervention
- Collaborated and planned across and among grade level and content area teams
- Administered formal and informal reading assessments throughout the year to track progress, identify learning needs and adjust instruction to meet the needs of groups of students and individual students
- Strengthened the implementation of Positive Behavior Supports and Interventions benefitting all students and groups of students
- Implemented Second Step curriculum by explicitly teaching social and emotional skills and strategies to all students

Facilities

Fernwood Elementary School opened in 1987. Our campus includes three wings and is nestled in a beautiful wooded area. The administrative wing houses the gym, cafeteria, music classroom, main office, workroom, four classrooms and a kitchen. The 100 wing includes the library and classrooms. The 200 wing is entirely dedicated to classroom space. The campus includes eighteen portable structures used for classrooms.

Fernwood is located in the most rapidly growing area of the Northshore School District. We are constantly planning to meet the needs of not just our existing families but also those we look forward to welcoming as the housing developments in our community are filled with new families. We've added portable structures to meet the growing needs of our students, staff and community.

Northshore is the 10th largest school district in Washington with more than 20,000 students in 20 elementary schools, six junior high schools, four comprehensive high schools, an alternative high school, a preschool program and an independent contract program grades 1-12.
