Between Sept 2018 and June 2019, all Kokanee Elementary K-2 students will increase their reading proficiency levels by ten percent as measured by Fountas and Pinnell IRR assessments, reading conferences and curricular assessments.

Facilities

Kokanee Elementary School was built in 1994 just off Highways 9 and 522 in Woodinville. The two-story, 63,437 square foot facility is well maintained, has 23 classrooms with pod spaces, a library, specialist classrooms, a full-size gym and 12 portable classrooms. The school is used extensively daily and in the evenings by sports teams and other community organizations.

Northshore is the 10th largest school district in Washington with almost 23,000 students in 20 elementary schools, six junior high schools, four comprehensive high schools, an alternative high school, a preschool program and an independent contract program grades 1-12.
