

Personal Data Collection Statement (Student)

- 1. It is often essential for you and/or your child to provide to Tanglin Trust School Ltd ("TTS") data about yourself and your family, or for TTS to collect information about you and/or your child, that is subject to applicable data protection or other similar laws in Singapore (your "Personal Data") from time to time in connection with your child's enrolment or prospective enrolment with us. Such Personal Data may include your and/or your child's identity documents, contact details, information concerning date of birth, image, marital status, nationality, racial or ethnic origin, past academic history, medical conditions, dietary restrictions, billing and bank information.
- 2. Such Personal Data is initially collected through the application and enrolment process. Other Personal Data is collected in the course of your child's time with TTS and in the course of your interaction with TTS (including as a participant in various activities associated with delivering the mission of TTS and its related entities). Personal Data may also be collected through your or your child's use of our email system or internet services. You are responsible for checking that any information that you provide to TTS is accurate and up to date.
- 3. Personal Data you and/or your child provide to TTS may be collected, used, disclosed and otherwise processed for the following purposes:
 - 3.1 determining eligibility for enrolment in TTS;
 - 3.2 assessing, monitoring and reporting on individual student performance, attendance and discipline;
 - 3.3 monitoring students' email communications and internet use in accordance with TTS' technology policies and guidelines;
 - 3.4 supporting students' learning through curricula and extra-curricular activities including but not limited to residential programmes, outdoor trips and external competitions in and outside of Singapore;
 - 3.5 providing pastoral care;
 - 3.6 providing healthcare and wellness services;
 - 3.7 provision of online services such as TTS internet portals;
 - 3.8 responding to your enquiries and/or feedback;
 - 3.9 processing your child's immigration related requirements where applicable, such as application of student passes;
 - 3.10 application for Ministry of Education approval for Singapore Citizens where applicable;
 - 3.11 facilitating payment for goods and/or services provided by TTS and/or a third party on TTS' behalf including verification of bank and credit card details with third parties and using the Personal Data provided to conduct matching procedures against databases of known fraudulent transactions (maintained by us or third parties);
 - 3.12 managing and communicating with you on all other matters relating to your child's enrolment and education with TTS; and
 - 3.13 managing and communicating with you on your participation in TTS' parent or community activities and programmes, or use of TTS' facilities and services provided to parents or the community.
- 4. In addition, Personal Data you and/or your child provide to TTS may be collected, used, disclosed and otherwise processed for the following purposes:
 - 4.1 conducting of statistical studies and analysis, either by TTS or by a third party service provider;
 - 4.2 supplying any goods and/or services which TTS or its selected vendors may offer or may require from TTS, including but not limited to bus services, food services, travel agents and hotels;
 - 4.3 where appropriate, promoting TTS to prospective students, including but not limited to the school's prospectus, magazine, website and other media platforms;
 - 4.4 where appropriate, sharing of information on the TTS Portal, for access by parents and employees;
 - 4.5 where appropriate, sharing of images of your child taken during school activities such as tournaments, trips, co-curricular activities, and special events, with other participants of the activity and their families;
 - 4.6 sending you information by post, telephone, email, SMS, messaging platforms and any other communication channels about the school, activities and events as well as carefully selected third parties;

- 4.7 for registration to the TTS Alumni, sending event updates and other communications to Alumni, connection between Alumni, for access by the Alumni department and other Alumni as per the consent given at registration;
- 4.8 responding to requests for information, including but not limited to academic records, references and information on the welfare of your child, from other schools or organisations which you or your child may apply for your child to join for study or work upon leaving TTS;
- 4.9 for outreach and engagement in support of TTS, its mission and community, whether conducted by TTS or its related entities, including the fundraising activities of Tanglin Trust School Foundation Limited; and
- 4.10 all other matters relating to the mission, function or operation of TTS as TTS may consider to be necessary or appropriate.
- 5. Personal Data provided to TTS will generally be kept confidential but you hereby consent and authorise us to provide or disclose your and/or your child's Personal Data for the purposes stated in clauses 3 and 4 above to the following persons:
 - any person to whom TTS is compelled or required to do so under law or in response to a request by a government agency;
 - 5.2 any person where public interest or our interests require disclosure;
 - 5.3 related entities of TTS, Tanglin Australia Pty Ltd and Tanglin Trust School Foundation Limited;
 - 5.4 any third party service provider who provides administrative, telecommunications, computer, data storage, data processing or other services to TTS, whether in Singapore or overseas;
 - 5.5 any third party seeking academic references;
 - 5.6 such professional advisors, consultants, sub-contractors or third party service or product providers as TTS may determine to be necessary or appropriate, whether in Singapore or overseas;
 - 5.7 such parents or guardians who act as class representatives of your child's class;
 - 5.8 any other persons participating in outreach and engagement activities in support of TTS, its mission and community, whether conducted by TTS, its related entities, affiliates or appointees (including participants in fundraising activities of Tanglin Trust School Foundation Limited); and
 - 5.9 any other persons to support your child's enrolment and education with TTS as well as for the operation of TTS as TTS may consider to be necessary or appropriate.
- 6. You have the right to request access to and correction of information about you held by TTS and you may:
 - 6.1 confirm whether TTS possesses or uses (within a year before the date of your request) your and/or your child's Personal Data;
 - 6.2 request that TTS provides you and/or your child with your and/or your child's Personal Data that is in TTS' possession or control, and information about the ways in which those Personal Data was used within a year before the date of your request, subject to exceptions provided under Singapore law;
 - 6.3 request that TTS corrects any error or omissions in your and/or your child's Personal Data;
 - 6.4 request that TTS makes information available about its policies and practices in relation to data protection;
 - 6.5 request that TTS makes information available about its processes to receive and respond to complaints that may arise with respect to data protection; and
 - 6.6 withdraw, in full or in part, your consent previously given to TTS. However, do note that withdrawal of consent may, in some instances, affect your or your child's enrolment prospects or ability to enjoy the benefits of your enrolment with us. Where applicable, TTS will inform you of the likely consequences of withdrawing your consent, and TTS will, as soon as reasonably practicable, respond to your request. In some instances, we may require a fee or deposit to cover the costs related to the request by you.
