In the winter of 2020, we engaged Independent School Management (ISM), a nationally recognized leader in independent school consulting, to help us complete a strategic Enrollment Management Assessment. This comprehensive assessment allowed us to examine our school’s admissions, enrollment management, and marketing and communications operations.

Parents were invited to participate in a parent survey, and we also completed student and faculty/staff surveys, all with an eye toward improving the St. Mary’s Academy experience.

One of the wonderful benefits for us was the opportunity to think deeply about who we are as a school and to consider the competencies our students will need to be successful now and in the future. One result of this work with our many stakeholders was the creation of our Portrait of a Graduate (POG) statements – our definition of what success looks like at the culminating points in each division, i.e. grades 5, 8, and 12. They are wonderfully aligned with our mission, vision and Loretto School Values, and speak volumes to who an SMA student is. We are proud of our work and are excited to continue to make our Portrait of a Graduate statements a centerpiece of our student programming, both in and out of the classroom.

As with any initiative or framework at SMA, our goals cannot be met, outcomes achieved, without the concerted effort and financial support of our stakeholders. In this year’s Impact Report, you will see examples of how funding specifically fosters our desired Portrait of a Graduate outcomes. In our combined fundraising efforts in 2020-21, more than \$1.2 million was raised to support our students. Within this, the Annual Fund monies of \$565,029 represent an increase of 17% over the prior year.

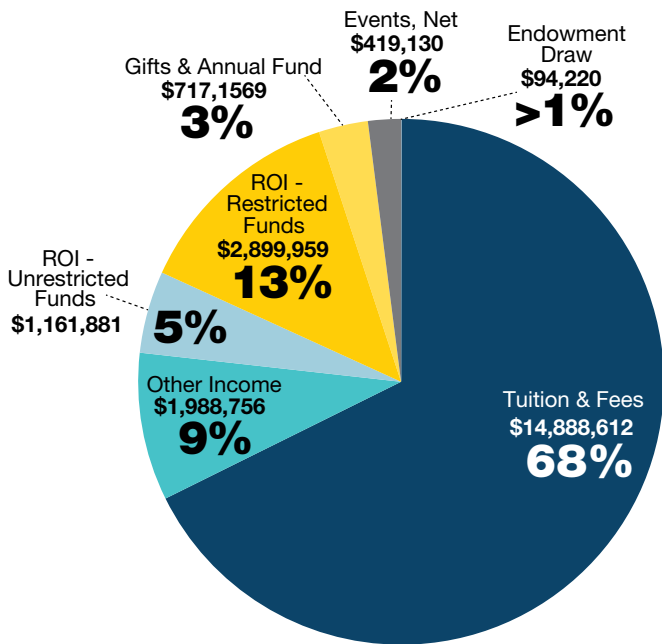

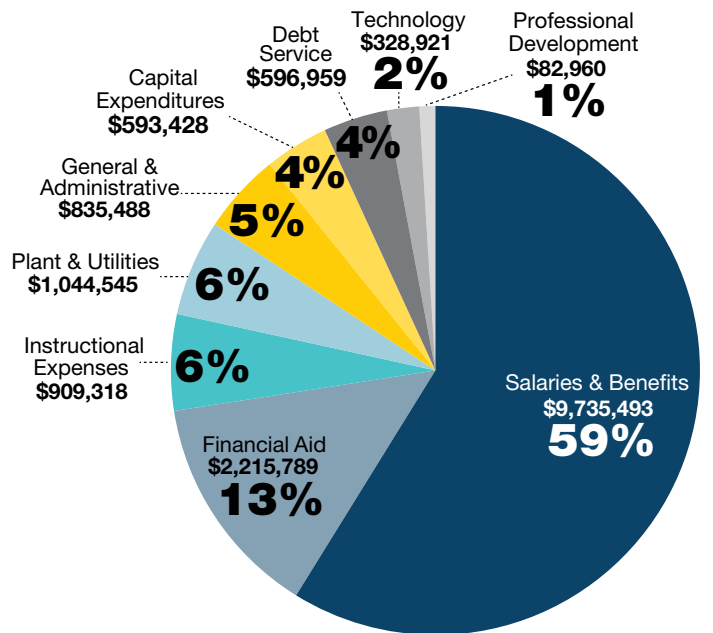

Act with Integrity.

St. Mary's Academy students are grounded in the Loretto School Values of faith, community, justice, and respect.

Starting in our Lower School, students are introduced to the Loretto School Values and explore what those mean in their lives and in the history of our school and the mission of Loretto. They follow monthly *Living Loretto* themes, with inspiration from the mission of our founders to work for justice and act for peace because the Gospel urges us. Students celebrate the International Day of Peace, connect with Loretto sister communities in Ghana, Guatemala and Pakistan, explore world holiday faith traditions, learn about peacemakers, observe Earth Day, and prepare for Foundation Day.

Our tuition assistance program is a way our community acts with integrity and stands for justice. Thanks to annual fundraising, more than **\$2.2 million** was awarded to a quarter of our student body for the 2020-21 school year. Tuition assistance is made possible through the generosity of our Gala supporters and endowment fund donors.



Exercise Empathy.

St. Mary's Academy graduates possess a high degree of compassion and cultural competency, and an understanding of service as a means to achieve equality.



SMA activity buses sponsored through the Annual Fund make it possible for students to take service trips throughout the Denver Metro area, such as harvesting vegetables in Weld County for area food banks, sorting items for Habitat for Humanity ReStore in Denver and Littleton, packaging medical kits at Project Cure in Centennial, and separating seeds at the Earthlinks urban gardens in central Denver. Independently, every High School student completes at least 100 hours of service at one of 130 organizations before graduation.

St. Mary's Academy graduates lead with purpose and from their strengths, becoming part of something larger than themselves.

The 2020-21 school year presented unprecedented challenges during the pandemic. With courage, confidence, and capability, SMA teams and clubs rose above. Regularly posting scores more than 40 strokes over their nearest competitors, SMA Golf won the school's first ever state golf title in 2021. They also earned two out of the top three trophies in individual standings—and received Metro League All-State Conference 1st Team honors, with our head coach, Ann Wolta Blackstone, named Coach of the Year.

After five undefeated rounds against challengers in Zoom courtrooms during the Colorado High School Mock Trial state finals, St. Mary's Academy was declared the winner among the 17 schools competing for the top prize.

SMA received top ratings for professionalism. "What goes with professionalism is integrity," said Denver County Court Judge Gary Jackson, who helped judge the Colorado Bar Association competition.



The Annual Fund pays for fees, uniforms, and equipment for clubs and athletics at SMA, paving the way for outstanding opportunities for all students to develop leadership skills.



Embrace Challenge.

St. Mary's Academy students know *how* to think, not just what to think, with the agility to solve challenges in a rapidly evolving world.

Whether it's participating in an international contest to research and create solutions to world problems or preparing an educational presentation for classmates, students require the tools and training of technology. SMA provides every Middle School and Lower School student with iPads and accessories—and invests in cutting-edge hardware and software that provide a secure environment on campus for all students, faculty, and staff. All possible through support from our generous community.

A team of SMA Middle School students invented a system to dispense powdered soap made from local resources, integrated with a water system installed by a community partner, at Malama Primary School in Malawi, Africa. It won them the top prize in the 2021 World Affairs Challenge that addresses United Nations Sustainable Development Goals. Several other social studies teams from SMA made it to the final round of the national competition.

Love Learning.

St. Mary's Academy students appreciate a diversity of experiences and discovering their passions.

We recognize the many benefits of the arts, including motor and neural development and the ability for students to express themselves and create together. The arts are a part of our Loretto legacy that we embrace with our whole heart.

Thanks to the Annual Fund, young musicians in Mr. McHugh's new music room explore sounds and rhythms with ukuleles, Djembes and other larger drums, boomwhackers, metallophones, xylophones and Latin American percussion instruments like cabasas and guiros.

For the visual arts, the Annual Fund provided for a Cricut Maker for Tinker Club objects and print-making projects in Mrs. Mansfield's art classroom. The High School ceramics studio under Mrs. Sniegowski was able to acquire a Blaze Barrel Raku Kiln. Over the years, the Annual Fund has also allowed for the acquisition of six more professional-grade pottery wheels.

In living the Loretto School Values of faith, community, justice and respect through twelfth grade at SMA, students leave with a firm sense of purpose in their passion areas. Graduates of St. Mary's Academy speak out and stand up for others—and it doesn't take a diploma to dive in.

To help students realize their potential and power to change the world, SMA has programs like Loretto Leaders, where students as young as Grade 4 gather with sponsors to research and discuss the Loretto School Values and find solutions to situations in the Lower School. In High School, students explore societal issues connected to their service learning work with their organizations of choice. Two New Endowment Funds Named by SMA Alumnae for Inspirational Women

Jean Elaine Karns DeVore

Patricia (Patty) DeVore MacMillan '64 has established an endowment for tuition assistance in honor of her mother, Jean Elaine Karns DeVore, who, along with her father, shared a goal for Patty to have the best education and made it possible by sending her to St. Mary's Academy.

The family started Patty at SMA in grade 4 and her brother in all-day kindergarten at a time when her father was battling cancer and her mother needed to work full time.

"Because the classes were so small, it was the first time I made friends at school," said Patty. "I thrived at St. Mary's and loved it."

She is proud of having graduated in the Academy's centennial year, with Mass at the Cathedral and a reception at the Denver Country Club. Patty was selected by the faculty for a state scholarship that she used to attend the University of Colorado. She majored in Geology, where there was only one woman graduate student and Patty became her field assistant as a freshman.

Patty went on to receive a master's in the field, as well as a secondary teaching license. Her work for Chevron in environmental geology sparked in her an interest in Public Health, so she proceeded to earn a doctoral degree in Nursing Public Health and taught nursing skills at the tribal college on Pine Ridge Indian Reservation among other work in the field before retirement.

"I feel so strongly that St. Mary's Academy High School is all girls. It's the very best way to promote all the ways of living that women are capable of. It's allowed...it's expected...it's the way it is. There are no limitations to what young women can do in the setting of St. Mary's," says Patty, who is also grateful to St. Mary's Academy for the lifelong friendships formed here.

Patty included her mother's maiden name of Karns in the endowment as a nod to the family's value of education. Patty's great grandfather was one of 11 kids on the farm in Iowa in the 1800s, and "every single one of them, including the women," attended college and became professionals across the Midwest.

Blair Hensen '08 and her grandfather, Ron Hensen, have set up an endowment for tuition assistance in honor of Sandra "Sandy" Monroe Hensen '58. The family feels that an endowment in honor of Blair's grandmother will continue to give in her name.

"One of Nana's biggest joys was to give to anyone who needed it. She had a huge heart for giving," says Blair.

Education was very important to Sandy, whose family made great sacrifices to send her to SMA, according to Ron Hensen. "At that time, city buses didn't leave the city limits, so Sandy had to take three buses to get to school." Ron met Sandy at a Lenten service when he was attending the University of Denver, and attended her St. Mary's Academy graduation in 1958.

Sandy persevered with education while raising a family with Ron. She received her college degree when she was 40 years old and her six children were in their teens. Sandy finished her master's in 1990 when Blair was born, and wanted to make sure that her grandchildren were educated well and able to pursue the things that they wanted to do. Blair went on to attend St. Mary's Academy by the grace of her grandparents and a scholarship.

"St. Mary's afforded me the opportunity to get an amazing education, and set me well up for college," says Blair, who has a private therapy practice in Montana. "St. Mary's Academy was definitely a place where I felt seen, and it helped me to develop and grow to do the work that I'm able to do today."

And so the legacy continues.

Endowment Fund
