The Planning Committee met today to interview architects for the new Ryerson Elementary School. The Committee originally looked at 15 firms before narrowing it down to 4. They were all very qualified. As a Committee, DRA was recommended to be the architectural design team for the new Ryerson Elementary School pending the referendum. The Committee will look to vote on this at the next BOE Meeting. If you have any comments or concerns please contact me or Galen to discuss the process and answer any questions you might have.

Mr. Cawley stated that all of the firms were excellent. A few things that stood out about DRA were their knowledge of the Town of Madison as well as their strong team support.

Superintendent Scarice stated that DRA was aggressive and competitive. DRA has done their homework on the needs of the District. DRA has looked at the other buildings in Madison so that the new structure would blend in with the New England look.

Ms. Keating stated the following:

The Negotiations Committee has not met. I would however like to make a statement. Just to clarify my report at the last BOE meeting since there was some confusion. On September 5 at the BOE Meeting, I wore the hat of 4 people. I was happy to fill in for my fellow Board Members by giving the negotiations report for John, the planning report for Jessica, chaired the meeting for Jean who had a family emergency and I gave my own finance report. I would like to state for public record that the negotiations committee report that I gave was both appropriate and necessary as we had come to an agreement with AMA and we were later voting to approve it. We worked hard on a fair contract with our Administrative Union and since we came to an agreement it was necessary for "John" that is me to give the final details in open session, discuss it in executive session then vote on it in open session.

#### **6.3.** Policy Committee

Ms. Stein noted the following:

The 5 policies listed below are going to the Board this evening for first reading.

#### #5113 – Student Attendance

As a result of recent legislation, it is necessary to remove language regarding a ½ day of suspension – it will now **not** be included in the calculation of student absences. (Refer to line 118 & 119). Legal references require updating as well.

# **#3542.4 – Lunch Charging**

Recent changes to National School Lunch Program regulations require that school districts have a "written and clearly communicated meal charging policy that ensures a transparent approach to the issue" (of lunch charging). Although we no longer participate in that program, we do have a Lunch Charging policy that requires updating, specifically, removing all references to the NSLP and the term "reimbursable". Legal references require updating as well.

# #4030.5 – Family & Medical Leave

The Family and Medical Leave Act of 1993 has been amended to include the National Defense Authorizations Act, which our policy does not state. Legal references require updating as well.

# **Curriculum**

CABE suggested (during the 2013 audit) to incorporate Policy #6070.4, Curriculum Adoption, into Policy #6070.1, Curriculum Development (and rescind #6070.4.)

CABE also suggested incorporating #6070.5, Curriculum Guides, into #6070.2, Curriculum (and rescind #6070.5).

Accordingly, we are proposing to rescind Policy #6070.5 and #6070.4 and modify Policy #6070.1, Curriculum Development, and #6070.2, Curriculum.
