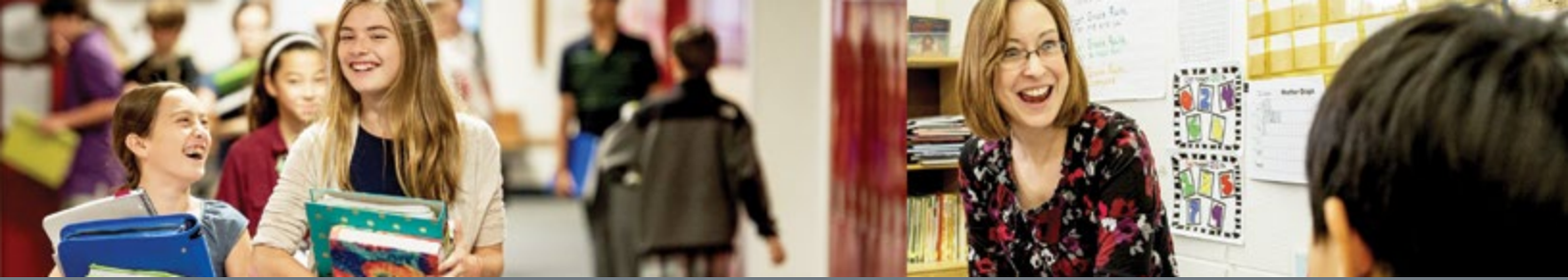
As an SCS alumnus and parent, it is my privilege and great pleasure to serve as Board President. I know you'll feel as proud as I do while you peruse the pages that follow.

As you peruse this Annual Report, I hope you feel the deep gratitude we have for each of you and the many ways you have chosen to support The Stanley Clark School.

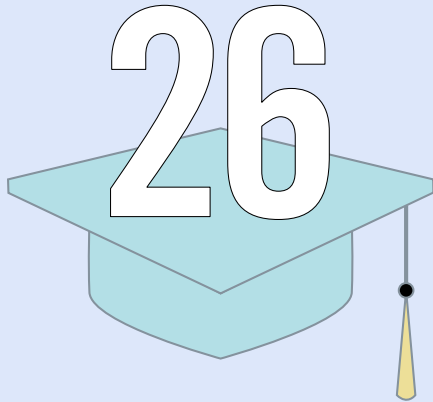

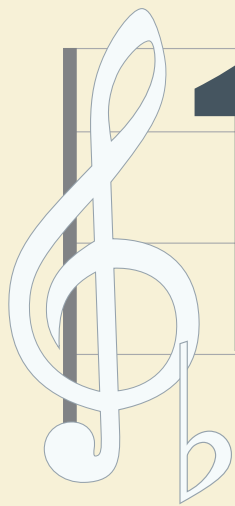

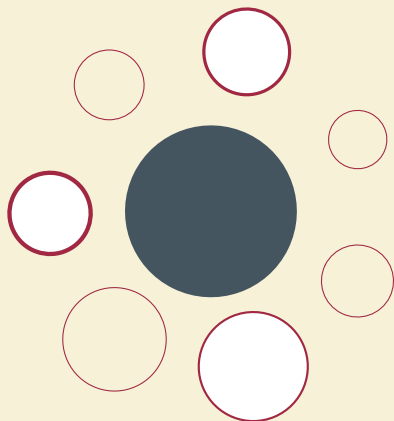

2016-2017 Financials

The Stanley Clark School's net assets as of June 30, 2017 were approximately \$13.0 million, including an endowment of approximately \$4.9 million. As with most independent schools, tuition is the largest source of revenue and covers approximately 81% of the school's budget. The school relies on income from its endowment and the support of the greater SCS family through charitable giving for the amount not covered by tuition and other revenues. Every gift is a direct investment in academic programming, our talented faculty members, and our facility at The Stanley Clark School.

The Stanley Clark School is a 501(c)(3) organization and is therefore exempt from federal and state income taxes. A copy of the school's federal tax Form 990 is available upon request. The school has received an unqualified opinion on its financial statements from its independent auditors, Crowe Horwath, for the past 29 years.



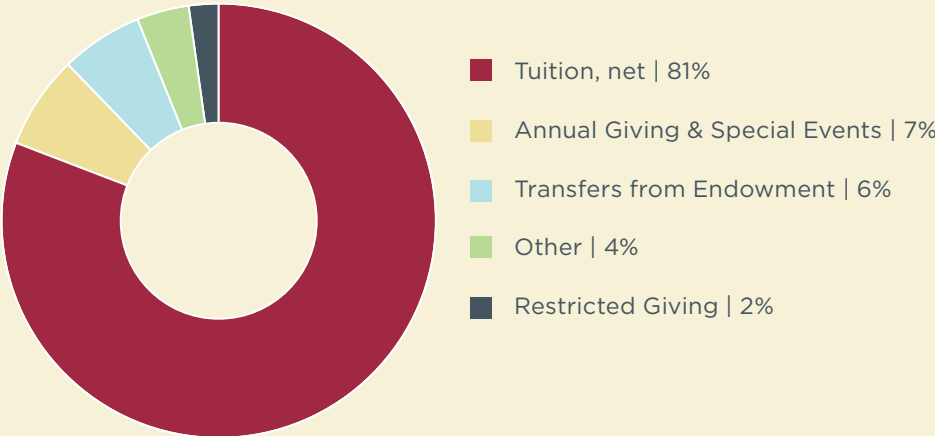

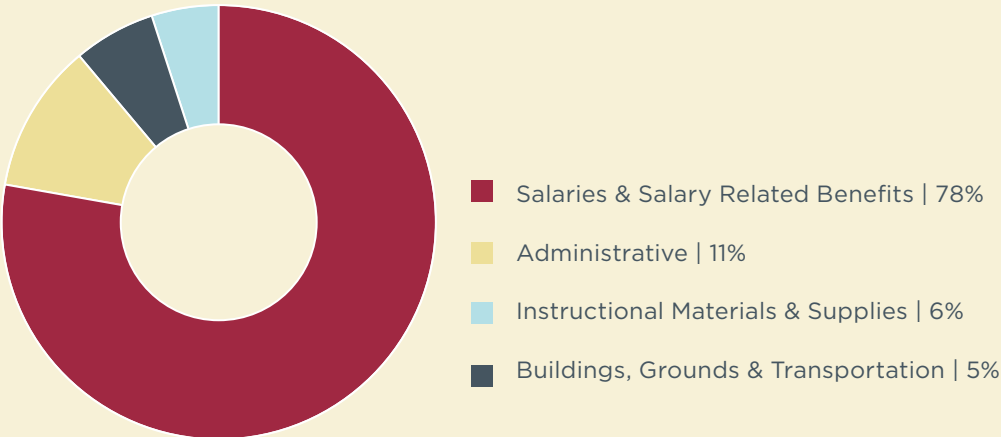

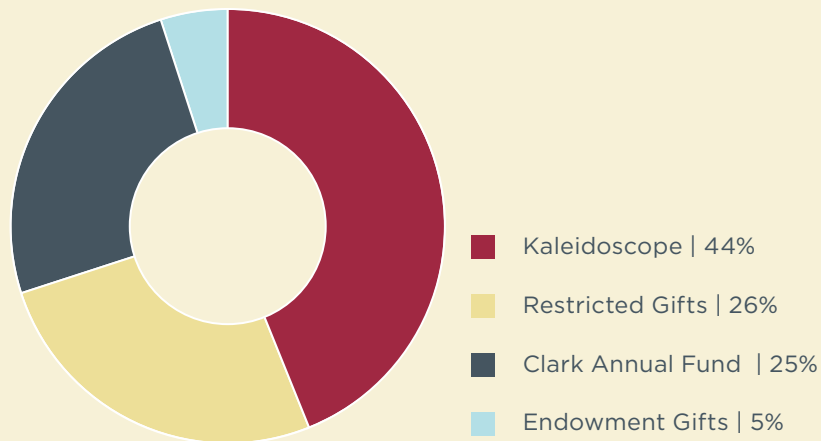
