RESOLUTION

R-15- 146

**ADOPT A RESOLUTION SETTING TAX RATES IN THE COUNTY OF SAN JOAQUIN
FOR THE FISCAL YEAR 2015-2016**

WHEREAS, the Board of Supervisors is required, pursuant to Government Code Section 29100, and by Board Resolution to set the rates of taxes on the Secured Roll on or before October 3rd of each year.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that an ad valorem property tax for the fiscal year 2015-2016 upon property situated in the County of San Joaquin, be levied and collected upon **EACH ONE HUNDRED DOLLARS (\$100.00)** of assessed valuation of said property after due allowance for delinquency applicable for the following fund, to wit:

The revenue from such tax shall be distributed to local agencies, school districts, county superintendent of schools and community college districts pursuant to law.

IT IS FURTHER ORDERED that the bond rate applicable to all utility companies and regulated railroads, based on unitary and operating non-unitary assessed valuation as certified by the State Board of Equalization, and as computed pursuant to the provisions of law shall be:

IT IS FURTHER ORDERED that an additional tax be levied and collected for the fiscal year 2015-2016 upon property situated within the County of San Joaquin, after due allowance for delinquency to make annual payments for the interest and principal on general obligation bonds approved by the voters prior to July 1, 1978, for **LINDEN COUNTY WATER DISTRICT, COUNTY SERVICE AREA NO. 12, and COUNTY SERVICE AREA NO. 14** to be levied and collected upon **EACH ONE HUNDRED DOLLARS (\$100.00)** of the assessed valuation, to wit:

IT IS FURTHER ORDERED that an additional tax be levied and collected for school purposes for the fiscal year 2015-2016 as hereinafter set forth so that provision will be made for the redemption on bonds and payment of interest and other indebtedness approved by the voters pursuant to law, as evidenced by the budget of the trustees of said districts (approved by the Superintendent of Schools), now on file in the Office of the County Auditor-Controller, to be levied and collected upon **EACH ONE HUNDRED DOLLARS (\$100.00)** of the assessed valuation of the respective districts, after due allowance for delinquency, to wit:

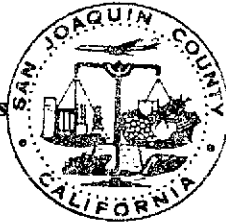


