PARENT/GUARDIAN RELEASE FORM

_____ High School is proudly participating in the Keys to Success Program. This incentive based program is designed to award students for their academic improvement. Your student will have the opportunity to win various prizes throughout their high school years for their academic achievements as well as the chance to win a grand prize and vehicle at the end of each academic year. Your high school's Keys to Success Contact Person (Key Contact) will be implementing the program at your school. The Keys to Success program will run from September through May. The grand prize and final vehicle giveaway will occur between March and May. For a complete list of the General Rules and the Hold Harmless Agreement please go to KTSUTAH.com.

Eligibility/Participation Requirements:

Participation in the Ken Garff Keys to Success car giveaway is voluntary and is open to all students enrolled at the high school in 10th, 11th or 12th grade and who have submitted a signed Parental/Guardian Release Form to the high school. The high schools will be authorized to distribute Key Cards to eligible students starting in September. These Key Cards will enable students to claim various prizes on the Keys to Success website at KTSUTAH.com as well as be included in the drawing for the grand prize and car giveaways. One grand prize will be given away at each high school, and five cars will be given away total. If a finalist is unable to attend the prize giveaway assembly or the car giveaway they may have an immediate family member (only) be a proxy through written notification prior to the assembly. Otherwise they will be considered disqualified and forfeit their participation.

Decisions:

Decisions, with respect to Key Cards, made by the high school administration are final and binding. Similarly, decisions made by the Success in Education with respect to prizes awarded in connection with the Keys to Success program are final and binding. The high school administration is responsible for and has full discretionary power concerning Key Card distribution and may, at any time, disqualify a student from the Keys to Success program.

Photography Release:

Students participating in the Keys to Success program will likely be covered and/or recorded by various media (e.g., newspaper, radio and television) during Keys to Success events throughout the year. This includes press releases that recognize students for their achievements, the grand prize and car giveaways, and other Keys to Success events. All photographs and interviews taken for Keys to Success may only be published with the consent of a parent or guardian. All photographs and interviews will not be published for advertising or promotional purposes other than those relating to the Keys to Success program.
