## Agreement for Student Internet Usage and School Policies Grades K-8

Just as we teach our children to be cautious with strangers, we also must teach them to be careful of strangers on the Internet. Consider putting your computer in a central location where you can easily supervise your child’s usage of the Internet. In addition, software packages that block unwanted or threatening information can be purchased.

- The Internet can be very educational and enjoyable; be sure to stress to our child that using the computer is a privilege. With usage, the following commandments must be followed:
- Never give out personal information (name, address, age, phone number) or use a credit card online without parental permission. It is a good policy to use an alias name on a child’s email.
- Never share a password, even with friends.
- Never arrange a face-to-face meeting with any stranger online.
- Never respond to messages, pop up ads, or websites that instill confusion and uneasiness
- Never use bad language, inappropriate pictures, or send mean messages.

***Any of these deliberate offenses is cause for revoking a student’s Internet privileges.***

The following precautions have been taken at Divine Child Elementary School:

- All websites and messages are filtered through the firewall and the file server
- Software is installed to block unwanted websites
- Students will use Chat rooms and IM (Instant Messaging) only as a learning tool; an open port is not available on our firewall
