1. Welcome/Approval of Last Meeting's Minutes

Co-Chair Parent Member Kyle Roche opened the meeting at 5:30 p.m. It was requested that all present sign in. Co-chair Roche moved that the September 14, 2011 minutes with minor typographical edits be approved. The minutes were approved without objection.

2. School Budget Summary

Principal Beatty presented a current school-budget summary recently presented to the faculty. He explained to the council how the line-item budget and the grade-level budgets interact. Principal Beatty expressed to the council that given the state of the economy, overall Mtn. View Elementary is in good shape financially. That said, the budgets are constantly monitored and fundraisers, including PTA fundraising efforts, are extremely helpful in the down economy, which has required cuts in budget and lower donations than in the past. Principal Beatty expressed his willingness to sit down with any Mtn. View parent to answer any questions with regard to school budgets.

3. School Improvement Plan

A draft of the 2011-2012 School Improvement Plan ("SIP") was circulated to the council members in the days prior to the council meeting. As of the meeting, two council parent-members had provided feedback, as had Mtn. View educators, and all feedback

had been incorporated into the draft before the council today. After reviewing the updated draft, the council recommended adoption of the proposed draft SIP and submission of the same to the district by next week's deadline; however, the council also agreed that members may still provide additional feedback to Principal Beatty by October 31, 2011 for consideration. Co-chair Roche agreed to advise all council members tonight via e-mail of this deadline

4. Viewing of School Trust Lands Video

The council viewed the School Trust Lands video in compliance with annual state law requirements.

5. Known Items/Issues for Next Meeting

Principal Beatty asked that the following items be included for the next agenda: Trust Lands Report Review, ISQ Survey Results. No one else currently has issues for the next meeting. Co-chair Roche reminded everyone to e-mail him with issues for the next meeting as they arise.
