1. Welcome/Introductions

Acting Chair Kyle Roche opened the meeting at 6:05 p.m.

2. Approval of April 29, 2015 Minutes

Acting Chair Roche moved that the minutes from April 29, 2015 be approved. The motion to approve the minutes was made by Tobin Hagen and seconded by Meggan Baxter. The minutes were approved without objection.

3. Discussion – Council Composition

Acting Chair Roche informed the council that only 1 application had come in for the Community Council Elections for 2015-2016 which meant that several positions needed to be filled. However, it was brought to his attention that the Council was not in compliance with our bylaws by having too many parents on the council. Acting Chair Roche recounted that previously the bylaws had been changed lowering the number of parent members to six. However, during the 2014-2015 elections due to clerical error the council went to eight members. Acting Chair Roche discussed the options the council had to fix this error. It was decided by the council that the bylaws would be temporarily amended to accommodate the council size. This election cycle would have three positions, the one application that applied before the election and two parent-members who will be nominated following the election. During the election cycle for 2016-2017 three positions would be open returning the council to the size dictated by the bylaws.

A motion to approve the temporary amendment of the Community Council Bylaws was made by Meggan Baxter. It was seconded by Tanya LaForce. There were no objections.

4. 2015-2016 Council Meeting Schedule

The Community Council must schedule a minimum of six meetings to be listed on the school website. It was decided that the Community Council be scheduled to meet on the following dates:

A motion was made by Tobin Hagen and seconded by Meggan Baxter. There were no objections.

5. Selection of 2015-2016 Officers

Nominations were opened for Community Council 2015-2016 Officers. Kyle Roche was nominated as Community Council Chair. Daniel Baxter was nominated as Community Council Co-Chair. Nicole Roche was nominated as Community Council Secretary. A motion to appoint these nominees was made by Meggan Baxter and seconded by Tanya LaForce. There were no objections.

6. Known Issues/Items for the Next Meeting

The Community Council was reminded of the Bond Elections and meetings. All were encouraged to attend. There was also a brief discussion of recess policies and morning playground procedures.

A brief parent meeting will follow this meeting to appoint parent-members to fill the vacant positions per the bylaws. The next meeting is scheduled for November 18, 2015 at 6:00 p.m. A motion was made by Daniel Baxter to end the meeting, it was seconded by Meggan Baxter. The meeting adjourned at 7:05 p.m.
