Reflections on the March for Life: Abortion In America

On January 22, 2010, about twelve students from Fairfield Prep participated in the 37th Annual March for Life in Washington, D.C. marking the anniversary of the Supreme Court decision Roe v. Wade which made it legal for a woman to receive an abortion any time during the course of her pregnancy. It was estimated this year that there were a record 500,000 people marching, 200,000 more than last year.

This simply goes to show that the abortion issue is growing in awareness and is becoming a m q t g " k o r q t v c p v " k u u w g " k p " q w t " p c v k q Thursday, January 21, and attended the Opening Mass National Prayer Vigil for Life at the Basilica of the National Shrine of the Immaculate Conception, in which many archbishops and bishops, 200 priests, 400 seminarians, and thousands of people were present. On Friday, January 22, we gathered at St. Aloysius Church with the other members of the Ignatian Pro-Life Network for the Mass for Life and then participated in a rally coordinated by the Jesuit Conference and Apostleship of Prayer where various members of Jesuit high u e j q q n u " c p f " e q n n g i g u " u r q m g " q h " v j g k t " u e we marched up to the famous steps of the Supreme Court, past the Capitol Building in protest of abortion and Roe v. Wade. Finally, we concluded our trip on Saturday, January 23, by participating in the 2010 Students for Life of America National Conference at Catholic University. All of this was an attempt to better understand the issue of abortion as well as to fight for life from the moment of conception until natural death. It was during this trip that I personally learned a lot about this issue and came to an understanding that this issue is significant. This issue which never seemed important to me came alive during this trip. This issue is not just an issue of religion and the role of God, but also common sense and an understanding of how we can make our world a better place. And because of this, as a matter of both logic and faith, I stand firmly against the practice of abortion in the United States for the following reasons:

When Does Life Begin?

The key to understanding and taking a stand on the abortion issue is by recognizing when life begins. According to science, life begins at the very moment of conception. Simply put, the life that is growing in the womb of the mother will never be a cat or a dog or a giraffe or a plant, etc. It is and always will be a human life.

Despite this, most Americans do not believe that life begins at conception; in fact, most people believe that life begins at the first heartbeat, which occurs during the first month of pregnancy. According to the Centers for Disease Control and Prevention, 77% of all abortions in the United States occur after the heart of the fetus has started to beat. So although it may seem as though a vast majority of Americans are for abortion, the American people are against a majority of abortions that happen in this nation. Thus, because most Americans believe that life begins either at conception or the first heartbeat, they are also at odds with the decision made in Roe v. Wade which made abortions legal up until birth.

Comparison to the Practice of Slavery

The argument over abortion can easily be compared to that of slavery. Some people thought that it was absolutely acceptable to enslave black men and women. Look at our society today. What used to be common practice and socially acceptable is no longer. But slavery was not once right and then wrong. It was always wrong, but many did not realize that. Too many people made excuses and attempted to defend the immoral actions taken against slaves who could not defend themselves. Today, we are doing the same thing to unborn children who cannot speak for themselves. Right now, people do not realize that those unborn fetuses are just as human as we are. Just like slavery, abortion was wrong in the past, is wrong now, and will always be wrong. Perhaps someday unborn humans will no longer be discriminated against.



The US Constitution

Very often it is argued that the reason abortion should be legal is because the Constitution be unconstitutional. But the fact of the matter is that Roe v. Wade was a result of judicial activism and is a case where the justices of the Court implied a right to privacy and then extended that right to privacy to include getting an abortion. Even though there may be an implied right to privacy in the Constitution, that also does not mean that that right cannot be limited or taken away. Thus, in this case, the Constitution does not permit a woman to choose. Even applying privacy to the use of abortion is a bit of stretch. The right to privacy granted in Griswold v. Connecticut which allows for the use of contraception should not be the same right to privacy granted in this case. There is not much private about an abortion. While sexual behavior in the home may be private and between two people, abortion involves a third party. Thus, even the argument about the right to privacy is a little weak and a stretch from the reality of what our Constitution really says.

Laws That Reflect the Morals of Society

People also suggest that the government simply has no right to tell people what to do. And, they are greatly disappointed by those who are supposedly attempting to force their morals upon others. I, however, would like to refute this claim by saying that for centuries our nation has created laws that correspond with the morals of the people. In fact, the Supreme Court itself has changed its view significantly matching the changes in society. Again, let us think about the practice of slavery many years ago. The Supreme Court once protected the existence of slavery, as well as segregation following the end of slavery. Many years later, the Court has changed its view and has overturned all laws that prevent equal opportunities for African Americans in this nation. One great example is the separate-but-equal doctrine. Rather than there being a change in the Constitution, there was a change in the views of the Court reflecting the changing view of society. Slavery and segregation were not once legal and good and later illegal and immoral. They were always illegal and always immoral yet the people and the Court did not recognize this fact until years later. The laws of land can be a reflection of the times and the morality of the people. And if the people of the United States wish to abolish the existence of abortion, then that should be okay. Roe v. Wade overturned many state laws across the nation which strictly limited the use of abortion in a particular state. Abortion is a state issue, and it ought to be the right of the states to make their own judgments about the practice of abortion. To those that say that the people in this nation cannot decide collectively whether the institution of abortion is an acceptable practice, you are misguided and ignorant of the history of this nation which has seen many laws that were pure reflections on the thoughts, feelings, and morals of the people.

The Help that Parents Deserve

As much as I would like the practice of abortion to go away, the prescription for fixing the abortion in our nation is not to simply ban the use of abortion and leave it at that. The best way to fight against abortion is to stop it at its source. We must remember why exactly people are choosing to have abortions in this nation. 25% of those receiving an abortion in this country say that they simply are not ready for a child, that the timing is wrong. 23% say that they could not afford to raise a child. Another 19% say that they already have children depending on them. 8% say that they have relationship issues and do not want to be single parents. Another 7% say that they do not feel mature enough to have this child.

And 4% say that having a child would interfere with educational or career plans. How can we stop abortion? We can stop it by preventing these problems, because it is irrational to think that people get abortions for no reason. When you take these issues away, you take away the need for abortion. This is why we must help women who are pregnant by giving them opportunities to be educated and work while caring for a child. We must financially assist parents who would perhaps struggle to run a household and care for the baby. We must provide counseling and create programs who feel that they are not ready and help those who are struggling with the difficult task of caring for children. And finally, we must extend a helping hand to those who are single parents and encourage them to work hard and care for their child. We have a moral obligation to assist those in need and to provide basic necessities for all people. Parents need our help. It takes a village to raise a child. And if we care about making the world a better place, we also will care about helping parents fulfill their obligations to their children. Being pro-life goes beyond supporting the unborn, it also means that we must provide for the basic needs of all and provide all people with an equal opportunity to live a fruitful life. That is what justice and morality are all about.

Attempting to Play the Role of God

Through the practice of abortion, just like most other life issues including the death penalty, people try to justify the action of taking a life. In doing so, what that person who is making the choice is really doing is trying to play the role of god. That is not acceptable. In the same way that Adam and Eve made an attempt to be like God by eating from the Tree of Wisdom, by taking the life of an unborn child we too are attempting to be like God. The Effect it Has on Society

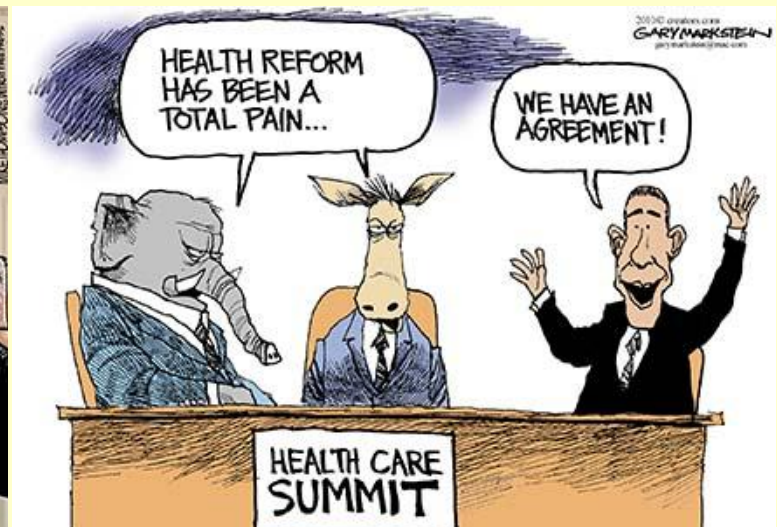
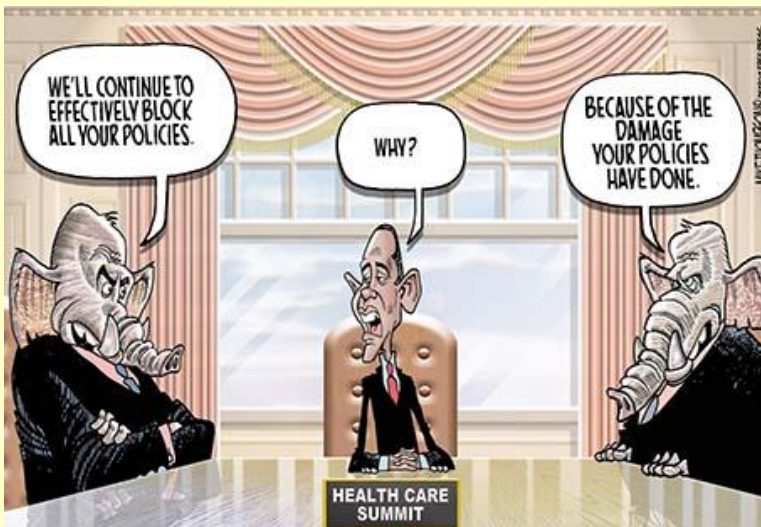
Conclusion

U.S.-Taiwan Arms Deal

On Friday, January 29, 2010, the United States announced that it had completed a deal to sell 6.4 billion dollars worth of arms to the Republic of China (ROC), more opposed the arms sale, and threatened sanctions if the U.S. went through with the sale.

The arms sale includes 60 Black Hawk helicopters worth \$3.1 billion, 114 advanced Patriot air defense missiles, a pair of Osprey mine-hunting ships, and dozens of advanced communications systems. The U.S. did not include any F-16 fighter jets in the deal, acquiescing slightly to Chinese opposition to the arms sale.

Beijing has taken a number of punitive measures to protest the arms sale. It postponed plans for visits between the U.S. and Chinese (PRC) militaries, and has put off a high level arms control meeting. Beijing is also considering sanctions against U.S. companies that sell arms to Taiwan. China's Defense Ministry said the punitive actions were made "in consideration of the serious harm and impacts on Sino-U.S. military relations" brought about by the arms sale. Beijing has also said that China will make further judgments as appropriate.

Taiwan as a sovereign nation, and Chinese Vice Foreign Minister He Yafei called the national security" and said China expressed its "strong indignation." The U.S. State Department responded by saying that the arms sale is a clear demonstration of the commitment this Administration has to provide Taiwan with defensive weapons it needs and as provided for in the Taiwan Relations Act," State Department spokesman P.J. Crowley said Friday. China claims if Taiwan ever declares itself an independent nation. The U.S. has promised to defend Taiwan in the event of that happening.

It wants Taiwan to be brought back into the fold of mainland China, and the only way for the PRC to do that is by force. However, the ROC is a sovereign nation, whether or not the PRC wants to admit it. They cannot be taken over by force. The U.S. may not formally recognize Taiwan as a sovereign nation, but it does treat Taiwan as one.

The U.S. has the right to trade with any nation, and it does not need the permission of any other nation to do so. Taiwan is a sovereign nation, and it deserves to be treated as such. The United States may choose not to formally recognize Taiwan so as to maintain diplomatic ties with the PRC, but that does not change the fact that the U.S. and the ROC are two sovereign nations. Two sovereign nations do not need the permission of a third, uninvolved nation to conduct trade. The PRC can not bully the world into giving it the power of dominion over another sovereign nation. The arms sales should have, and did, proceed over the objections of the PRC.

Barack Obama will always be remembered as America's first African American President. This is very important to history and civil rights; however, I hope for the sake of our country, that he will be remembered more for his accomplishments as Commander in Chief.

Mr. Obama inherited many different problems when he came to office that threatened the very livelihood of our country. First off, the financial system was at an all time low, and our economic situation was being compared to The Great Depression. Next, our country was in a severe debate over our flawed health care system. The United States was also fighting two wars in the Middle East, neither with any end in sight. These unsettling facts, along with the truth about the torturing at Guantanamo Bay, and numerous other allegations against our government, gave our country a very low approval rating both foreign and domestically. In the face of all of these unsettling problems, Barack Obama was sworn in as the forty-fourth President of the United States in January, 2009.

There are three main problems President Obama has had to deal with in his first year as President: The economy, health care, and our military status in Iraq and Afghanistan. First, the President started with the economy. In February 2009, The American Recovery and Reinvestment Act was passed. This act applies money toward federal tax cuts, expansion of unemployment benefits, and many other areas in need, including domestic spending on education and health care. The bill was very controversial, and no Republicans in the House voted for its passage, while only three Republican senators approved it. This bill, while opposed by the majority of Republicans, was necessary in our economic state, and it is still having a large effect almost a year later. While the stock market has had an incredibly strong rise, the job and housing problems continue to worsen. The health of our economy is necessary to the well being of every American citizen. The coming months are crucial for our Country to get back on track.

Next, we come to health care; which system, currently in place, is severely flawed. As of September 2009, 46.3 million Americans did not have health insurance. This number is staggering. Many people simply cannot afford the premium bills and co pays that go along with a normal health care plan. For those who have health insurance, this is extremely expensive. If you have a preexisting condition, this usually leads to you being denied by an insurance company.

According to President Obama, the plan is to provide health insurance for those who do not have it. It will provide insurance for those who have health insurance. The President has worked extremely hard on this issue, and in late 2009, both the House and the Senate passed different forms of health care bills. A single bill must still be put together from each separate bill and again be voted on. This presents a problem, because the Democrats have just lost the super majority vote, which would have overridden a filibuster. This makes passing the bill much harder, and the current health care bill may not be passed unless certain modifications are added. This has been seen as a problem. The President will decide whether he will continue to strongly push for healthcare reform, or to back down and focus more on other issues, such as the economy.

Finally, the third main point President Obama has touched upon during his first year as President is the issue of the two wars the United States is currently fighting in Iraq and Afghanistan. Obama promised that by August 31, 2010, the United States will end its combat operations in Iraq, having about 90,000 troops leave, and a force of about 40 or 50 thousand troops staying to continue to advise and train Iraqi security forces. This is a significant move in US policy, and a direct change from the policy of The Bush Administration. The Iraq War has been hotly debated since its start in 2002, and many people have agreed and disagreed on whether it is a just war. I think that the fact that we went to war in Iraq was a move not based on human rights or safety, but one of money and downright greed. Over 4,000 American soldiers have died, but perhaps the most shocking figure is that over 100,000 innocent Iraqi civilians have been killed. 100,000 of those lives could have been spared. That is why it is so important that the US withdraws from Iraq. We need to get out not only to save American lives, but also to save Iraqi lives.

This continues to the war in Afghanistan, which is very different from the conflict in Iraq. The United States has occupied Afghanistan for eight years, and the whole time, our country has not had a clear goal.

With the growing threat of the Taliban and Al Qaeda regaining power, in late 2009 President Obama pledged to add 30,000 more troops to the total armed forces count in Afghanistan. These soldiers will support the troops already in the region, and help train and protect the new Afghan government. Most of this crisis could have been averted if Obama had taken a look at history. 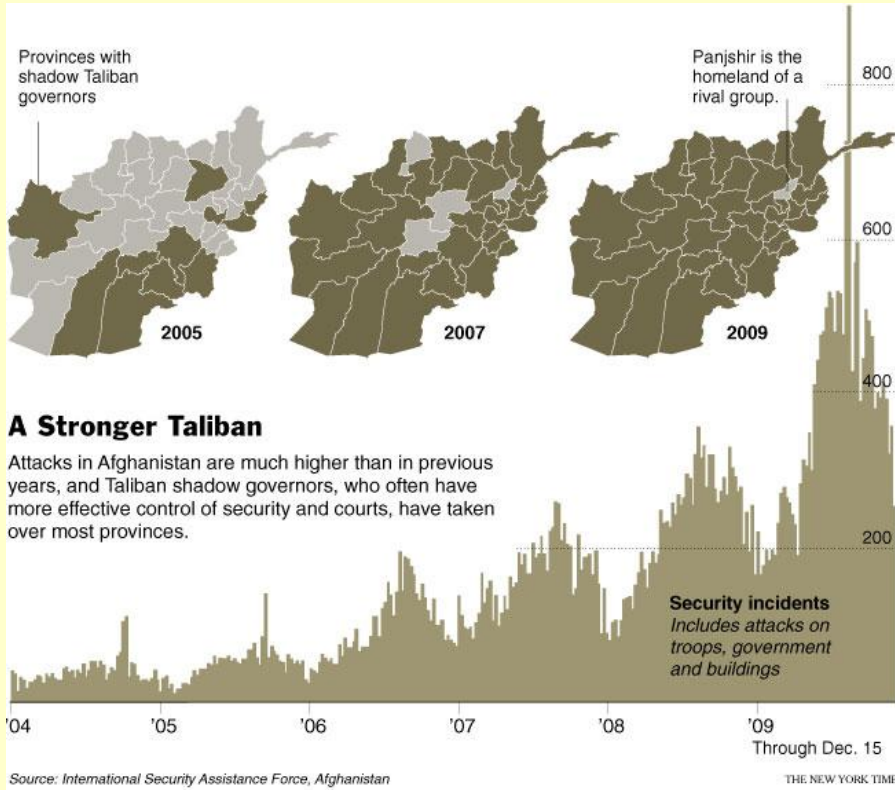


War of Words

If anything, we are losing the war. The Taliban are gradually taking control of more provinces, and as you can see by the graph below, attacks have increased dramatically over the past five years.

In 1954, Nasser was assassinated by a suspected Brotherhood member, although the group has denied any responsibility. In the 70s and 80s, the organization supported the Prime Minister Anwar Sadat, until he agreed to a peace agreement with Israel in 1979 and was assassinated by a non-Brotherhood member in 1981.
