SUBJECT: WASC/CDE Focus on Learning Training, Part Three of a Three Part Series

The Accrediting Commission for Schools and the California Department of Education will be holding fall follow-up sessions for self-study coordinators of schools conducting 2012-2013 studies. The following self-study topics will be covered at the trainings:

- Inclusion of all staff and representative stakeholders in the self-study (e.g., schoolwide focus groups and home groups)
- Evidence analysis of student program and its impact on student learning based on the (1) expected schoolwide learning results, (2) academic standards, and (3) schoolwide criteria
- Summarizing the findings and identifying the strengths and growth areas
- Updating the current Single Schoolwide Action Plan for Student Achievement based on the self-study findings and identified growth needs
- Review and refinement of the follow-up process to monitor the accomplishment of the Single Schoolwide Action Plan, including the maintenance of the student/community profile
- The visit, including the changes in the accreditation status process
- The refinement of the Single Schoolwide Action Plan after the visit
- Annual review and recording of action plan progress, including the analysis of student achievement data
- Annual refinement of the Single Schoolwide Action Plan for Student Achievement
- Other concerns expressed by the participants
