

AFFIDAVIT FOR COMPULSORY EDUCATION EXEMPTION  
DAVIS SCHOOL DISTRICT

Under Utah State law a parent/guardian is required to enroll and send a school-age minor (6-18) to a public or private school. A school-age minor shall be excused from attendance by the local board of education if the school-age minor's parent/guardian files a signed and notarized affidavit with the school-age minor's school district of residence. The signed and notarized affidavit filed with the District Student Services Department shall remain in effect as long as the school-age minor attends a home school, and the Davis School District remains the school-age minor's district of residence. School-aged minors excused from attendance under the law shall be issued a Compulsory Education Attendance Exemption Certificate for Home instruction annually from the District.
