Agenda: *Meeting commenced at 4:00pm*

1. **Welcome & Introductions** – *Ashley welcomed the council and led out on introductions.*
2. **Review and approve minutes—Angela** – *Minutes from previous meeting were read and reviewed. Cliff Calhoun motioned to approve, Sharlyn seconded the motion and the council unanimously approved the minutes.*
3. **Principal's Report on school items**
 - a) *Discuss previous year's SAGE/CRT results – CRT data showed Math and Language scores or percent correct. Our school averaged scores of 51% to 55%. In regards to our school report card we would be receiving a grade of C. SAGE data is the measure of percent proficient in ELA, Math and Science for 3rd-6th grades. Most of our scores were right where they should be. The only percent that was concerning was the 6th grade Math score of 20% proficient. The student body is using the computer program Reflex Math to help improve their retention of math facts. Of the 761 Students in the school 690 are using the program – Kindergarten is not using at this time. From the 690 students – 1,769,943 math facts have been retained - 72,565 facts have been a gain in fluency – that is an average of 105.2 facts per student. Fluency per student is between 17% - 52%.*

We were reminded by Mr. King that 2016-2017 Community Council voted to allocate \$58,000.00 of last year's budget to pay for Teacher Assistants to help teachers meet the goals they set for this year. We will continue to evaluate progress on goals at upcoming meetings.*
