## **District Parental Involvement Policy**

### Part I. General Expectations

Southgate Community School District agrees to implement the following statutory requirements.

# Part II. Description of How the District will Implement the District Wide Parental Involvement Policy

Southgate Community School District agrees to implement the following statutory requirements.

- The school district will support programs, activities and procedures for the involvement plan under Section 1112 of ESEA.
- District Curriculum and State/Federal Program Director will ask buildings to advertise the district wide parent meeting and help recruit interested parents.
- An annual district level meeting for parents who will review policy, disperse parental involvement funds to the buildings, review school-home compacts, and plan district level activities.
- Meeting announcement, minutes and decisions will be conveyed to Title I, Part A parents using multiple media avenues including but not limited to: district website, board of education presentations, building level dissemination and local cable TV as appropriate.
