### School Description and Mission Statement (School Year 2017-18)

Sutherland School is located at 550 Spring River Circle, Stockton, California and was dedicated by the Board of Education on December 17, 1992.

Our attractive school is equipped with an administration/kindergarten building, a library building, a classroom building with eight classrooms, a classroom building with four classrooms, and a computer lab, a multi-purpose room and cafeteria, eight portable classrooms, and a well-planned playground.

Safety, cleanliness and maintenance of our facilities are high priorities. The custodial staff regularly inspects the campus and requests repairs as needed. Teachers and staff collaborate to make the Sutherland environment safe.

A Learning Opportunity Class servicing a maximum of 15 students throughout the District is housed at Sutherland School. Students attend for a minimum of three months and a maximum of one year. These students are the most socially at-risk in grades 3-5. The program is provided with an intervention program focusing on social behavior. The students are given a lot of practice in life skills dealing with difficult situations. Academically, they are given the core curriculum. A very important component of this program is parental involvement. Parents are expected to be involved at any time their student experiences difficulty, and meet once every other week to discuss ways they can help their child experience more positive social growth. A full-time instructional assistant helps in this classroom.

G.A.T.E. students were identified and served in cluster classrooms. Classroom teachers offered differentiated instruction to meet the needs of all students, including those identified as G.A.T.E.

There is an after school program funded by a grant received by the State of California. The Bridge Program is offered daily from 2:40 to 6:00 p.m.

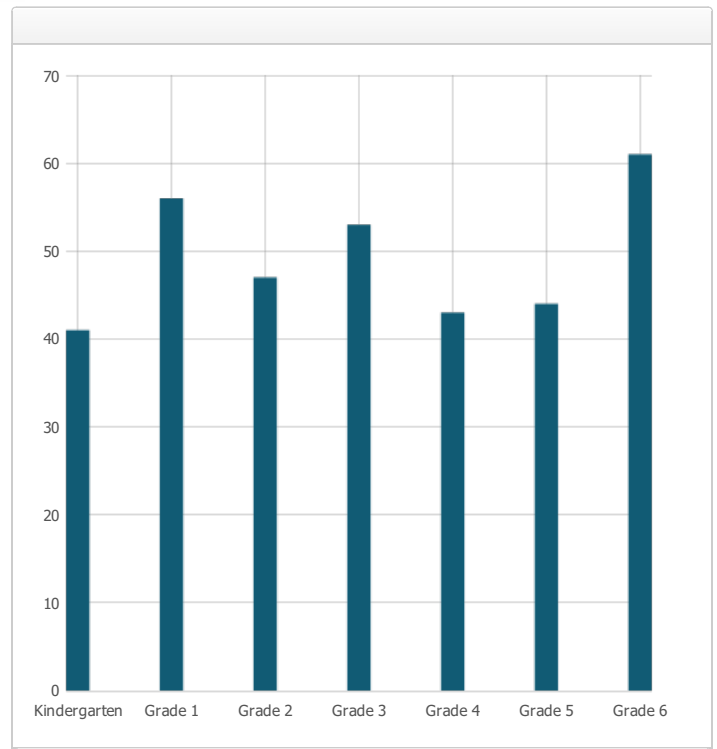
Sutherland School is a Program Improvement school. We have developed a restructuring plan based on scientific proven components. Teachers meet weekly to plan curriculum and evaluate student progress. Students are assessed regularly to help staff guide instruction. Interventions including: Language, Small Reading Groups, Before/After School Tutoring, and Summer Title 1 tutorials are provided to identified students.

We make every effort to help students with limited English skills. We have a limited English proficient student population of over thirty percent.

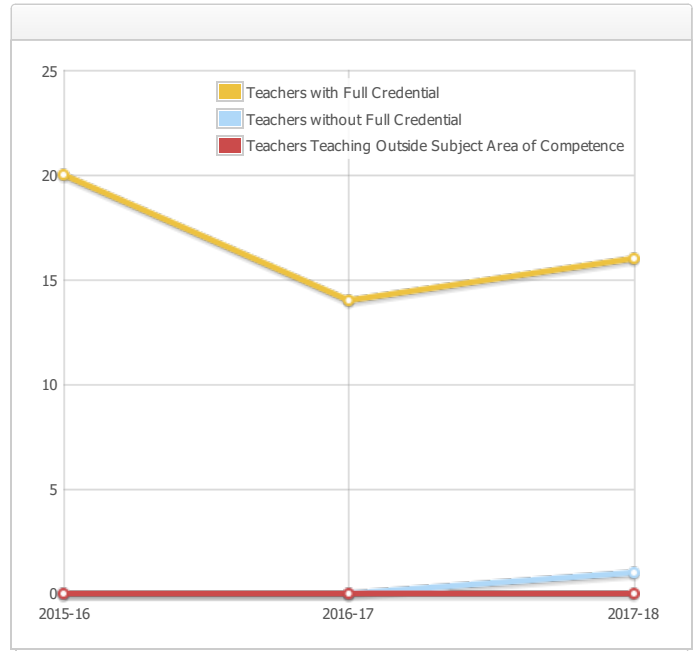

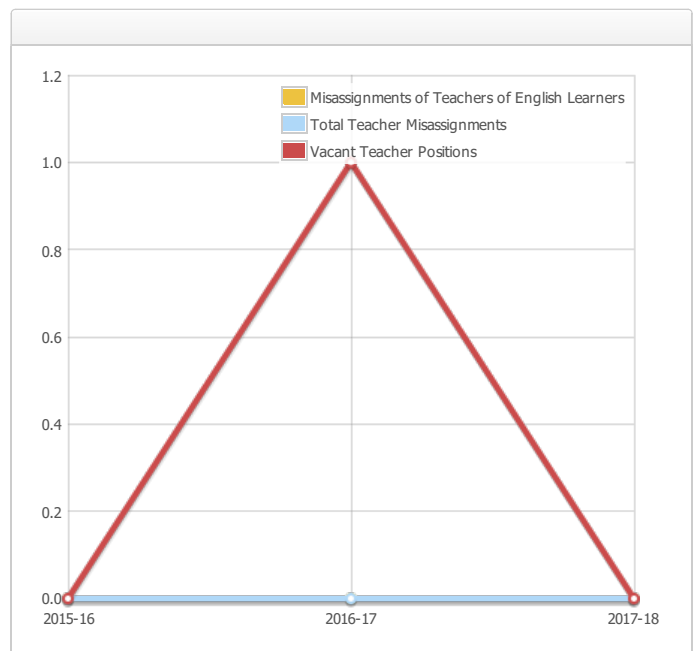

## School Facility Conditions and Planned Improvements

### AGE OF SCHOOL BUILDINGS:

This school sits on 10 acres and was built in 1991.

### MAINTENANCE AND REPAIR:

The Sutherland School facilities' condition, including grounds and restrooms, are very good based on custodial staffing, a regular district painting and maintenance schedule and funding available for equipment and supplies. Custodial workers are assigned based on a district formula to ensure equity. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

### CLEANING PROCESS AND SCHEDULE:

A scheduled maintenance program is administered by Lodi Unified School District to ensure that all classrooms, restrooms and facilities are well-maintained and in good repair. Staff works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

### DEFERRED MAINTENANCE PROJECTS: N/A

**MODERNIZATION PROJECTS:** 2012 Fire alarm & intercom were replaced. 2013 HVAC controls were replaced & siding repairs were completed. 2014 Entire site was re-roofed from single ply to built up roofs and various flooring were replaced in many rooms. 2015 Added access control, cameras, rod iron fence and no climbing fence for security. 2017 Replaced flooring in student restrooms.

### NEW SCHOOL CONSTRUCTION PROJECTS: N/A

Lodi Unified School District takes great effort to ensure that all schools are clean, safe and functional. ### Professional Development

Lodi Unified School District is committed to supporting school district staff through quality professional development. Teachers receive professional development each year. A variety of data is used to determine the focus of staff development in Lodi Unified School District. Data from state assessments, district assessments and teacher surveys assist us in identifying areas of concentration. Our current focus is on common core in mathematics and English language arts, social science, core practices, assessment, and technology. Our goal is to continue to have a highly trained professional staff that supports the success of all students in the classroom. We provide several programs and a variety of strategies to allow staff full access to training.

Teacher Induction Program (TIP) is available to newly credentialed teachers through the district. Teachers participate for two years in workshops, trainings and work closely with an assigned mentor teacher. Non-instructional personnel are offered training in technology, budget, and job specific content. Many Paraprofessionals take advantage of district offered training. Instructional coaches are available to work with staffs on-site in their classrooms as well as through district sponsored events.
