



RESIDENCY AFFIDAVIT

Residency requirements when the parent/legal guardian **does not** own or lease the residence (see residency requirements below). **Residency affidavit must be updated in the spring of each year.**

RESIDENCY REQUIREMENTS

Parent/Legal Guardian: A completed and notarized residency affidavit, parent photo Id, and **two (2) proofs** of residency with parent/legal guardian name and current address are required. See Categories A & B below for acceptable proofs. Acceptable proofs can be from either category.

Homeowner: A completed and notarized residency affidavit, homeowner's Id, and **three (3) proofs** of residency in the homeowner's name is required with at least one (1) proof from Category C and two (2) proofs from Category D.
