### Student Drive Requirements:

1. All drivers must be at least 16 years of age and possess a valid state driver's license.
2. All student drivers must display a parking permit which requires written parental permission and a Vehicle Information Form to be on file in the Upper School office. A parking permit must be purchased from the office and is only good for one school year.
3. Students must adhere to the 15 MPH speed limit on school property.
4. Students must park in designated parking area according to grade level. Parking outside designated areas is prohibited.
5. Students are expected to be extra careful in observing traffic and vehicle laws in the community around the school.
6. No one is to be in the student parking lot during school hours. Only MCA student drivers and authorized passengers are allowed in the parking lot before and after school.
7. Students may not linger in their vehicles upon parking. Loitering in the student parking lot is prohibited at all times.
8. MCA reserves the right to revoke parking privileges for any academic, attendance, or disciplinary issues that arise.
9. Any driver receiving five (5) tardies in one semester will lose parking privileges for one (1) week. An additional three (3) tardies in the same semester will result in another one (1) week suspension of parking privileges. If parking privileges are suspended for a third week, the student may not be allowed to park on campus for the remainder of the semester. Students that lose this privilege may not park on or near the campus and walk to the campus from this location.
10. MCA reserves the right to inspect any automobile vehicle on our property with reasonable suspicion.
11. Any form of dangerous or reckless operation of a vehicle can result in permanent loss of driving privileges.
12. MCA is not responsible for any damages incurred to a vehicle on it's property.

***If at any time an adult reports your name or vehicle due to a violation of the above, consequences will be administered.***
