#### DISCUSSION

#### Finance

Theresa McLachlan reported to the board that she met with a representative from SETSEG who will be our new insurance carrier for property, casualty and workers compensation. We are moving away from being self-funded for workers compensation. She was provided with quotes for 2014-2015, for the workers comp policy; the first year we will have a savings of approximately \$80,000 based on the claims we have had to pay during 2013-2014. Our property and casualty insurance for next year will save us approximately \$25,000. With SETSEG they give their members dividends every year, being a new member we will not qualify until after three years.

She is still continuing with the process of working on the final amended budget for 2014-2015, as well as the revised Deficit Elimination Plan for 2014-2015. We still do not know the final number on the foundation allowance so it does make it difficult to finalize at this time. It is anticipated the State Budget will come out June 1. Our student count and enhancement millage will also be factors in the budget process.

# Superintendent's Report

Mr. Grusecki told the board he had the opportunity to speak to Rep. Andrew Kandrevas at the Kiwanis Essay Contest. Rep. Kandrevas did say the budget would be out of Lansing by June 1. When asked about the foundation allowance, Rep Kandrevas would not commit to the amount that we will be getting. There are three versions of the budget, Executive, House and Senate. It is the hope that the House and Senate versions will be better than what the Governor has planned.

The renovations at Gerisch, to prepare for Beacon, are moving right along. They are in the process of painting. GCA will strip and wax floors. By June 16 the movers will start to move items from Beacon to Gerisch. Mr. Grusecki thanked Nate Lay for overseeing the construction project, which is on time and should be complete by the end of the week.

He commented on the Asher Adult Education Honor Society induction ceremony and encouraged board members to attend. He congratulated the Davidson Middle School students for their award winning essays. Four \$100 scholarships were awarded to students.

Mr. Grusecki mentioned that Ms. Hainrihar had been in so they could review a lot of information. They also spent time at Grogan with members from the Lions, including Matthew Stafford. The rest of the day was spent in meetings with various department representatives and staff members.

Ms. Hainrihar will begin on June 2. He encouraged the board to attend as many end of the year functions as possible.

# CITIZENS COMMENTS

Mr. Larry Hill and Mr.Al Worley from Cunningham Street addressed the board with their concerns regarding parking issues around Grogan Elementary School. Pictures were presented to the Board showing various areas of concern; illegal parking, garbage thrown on residents' lawns, damage to property from parents driving onto their lawns when turning around in their driveways. They also commented on the unsafe practices of parents when crossing their children.

Mr. Knott and Dr. Pomponio assured Mr. Hill and Mr. Worley that the Safety Committee as well as building administrators will continue to address these issues and concerns.

Mr. Grusecki commented that this has been an ongoing issue and unfortunately we have people that have no regard for the safety of others or respect for their property. He said we will continue to be in touch with Public Safety Director Tom Coombs to address these concerns.

Ms. Reed-Hall also asked that parents be aware of the usage of social media and reposting issues, asking that everyone exercise responsibility and respect when using that format.

Mr. Hayhurst wanted to share an article from Michigan Education Digest-"(GOP) Legislators are considering moving school testing authority from the Michigan Department of Education to the Michigan Department of Treasury.

MLive reports that the move is being considered because of a disagreement between Republican Legislators and the Michigan Education Department over what state test will be administered next year.

Legislators have added a requirement that the MEAP test be administered for the next two years. But the MDE has indicated that doing so would put Michigan at risk of losing federal funding."

Mr. Hayhurst commented 'I assume this is being considered because of the wonderful job Treasury has done funding schools in the past'. He encouraged everyone to remember this at voting time.

He concluded by expressing his thanks and gratitude to Mr. Grusecki for his leadership through some difficult times. Saying it has been both a privilege and an honor to have walked the path with Mr. Grusecki.

Mr. Knott thanked Fire Marshall Michael Sypula for his assistance at Fordline with fire drills. He helped answer questions about procedures. Ms. Reed-Hall said we were blessed to have Mr. Grusecki be a part of our school district. She has a great deal of respect and admiration for him, commenting on how small town values are never too big.

Mr. Hayhurst wished Mr. Grusecki luck and encouraged him to enjoy playing the golf courses up north.

Mr. Knott concluded with his own well wishes and concurred with the thoughts and comments of his fellow board members. He thanked Mr. Grusecki for his professionalism and asked him to enjoy his retirement.
