Overview and History

The 21st Century Community Learning Center program is authorized under Title IV, Part B of the Elementary and Secondary Education Act (ESEA) and *No Child Left behind Act of 2001 (NCLB)*. The 21st CCLC grantees in Georgia are required to provide academic enrichment opportunities in before-school and after-school activities (including the summer) for Title 1 schools with high levels of students receiving free or reduced lunches. These activities will help advance student achievement and meet the local and state academic standards in the areas such as reading, mathematics, and science.

The Rabun County 21st Century Community Learning Center (RCCLC) Project was awarded during the summer of 2014. The Rabun County project established a program targeting 250 at-risk students at Rabun County Primary School, Rabun County Elementary School, and Rabun County Middle School who performed below proficiency in reading and/or mathematics on the Georgia Milestones End of Course Tests or have difficulty passing their classes. The RCCLC operated from 3:15 to 5:40 pm Monday through Friday for 26 weeks during the school year.

Mr. Mark Wilcox serves as the Program Director of the current project. Academic and personal enrichment were delivered by certified and/or trained personnel that supplemented the traditional school activities and allowed for academic and personal growth. The project focused on meeting the needs of all students served and their families.

Student Attendance and Enrollment

During the 2015-2016 school year, RCCLC enrolled a total of 360 students with an average of 230 students per day. The average daily attendance of all students enrolled was 63.9%. When isolating Regularly-Participating Students, a total of 308* students were enrolled. Data for All Students and Regularly-Participating Students per site are included in the table below:

In addition to the enrollment numbers, demographic information on the Regularly-Participating Students was collected on Gender, Race/Ethnicity, Special Education (SWD), and Economically Disadvantaged (ED). The table below* indicates 161 of students were female compared to 147 males. Observing Race and Ethnicity data, White students attributed to 227 of the population while Hispanic or Latino (70) and Other (11) were also served. The opportunities provided to students in the RCCLC program included service to 35 Students with Disabilities and 244 economically disadvantaged students.

Program Operation

The RCCLC operated from August 31, 2015 until April 19, 2016 met Monday through Friday each week from 3:15 to 5:40 pm.- The RCCLC served a total of 360 students, 308 regularly participating, by providing enrichment activities, both academically and personally,-for 12 hours across 26 weeks. The table below indicates a total service time of 130 days.

During the grant schedule, students were provided a daily snack, homework assistance, personal enrichment and reading and math support.

Quality of Staffing

The RCCLC program employed 1 Program Director, 4 Site Coordinators, 35 teachers, 30 paraprofessionals, 1 Data Entry Specialist and 8 non-school-day staff-Bus Drivers. We also had 4 volunteers on a regular basis. Of the staff members, a total of 35 are certified by the Georgia Professional Standards Commission and are responsible for classroom instruction in the program. With 121 PS, 150 ES, and 37 MS regularly attending students, the *Student: Staff Ratio-Teachers/Paras* (308/65) of **5:1** satisfied the requirements set forth by the guidelines.

Professional learning opportunities provided to the faculty and staff of the RCCLC program varied in nature and was specific to meeting the needs of the program. The 2015-2016 Professional Development Plan included the following:

Other Observations

Parent and student surveys were administered to reflect the questions suggested by the 21st CCLC program. Parent participation greatly increased from last year's 84. In 2016, parent participation totaled 196. The results below indicate success of the RCCLC program.

Parent Responses (n=196):

- 71% "Agree" or "Strongly Agree" the program helped improve their child's behavior.
- 85% "Agree" or "Strongly Agree" the program helped their child complete and turn in his/her homework in a timely manner.
- 96% were "Very Satisfied or Somewhat Satisfied" with the after school program.
- 57% of children typically stayed at home with a sibling, parent, guardian, or sitter prior to participating in the program.
- 87% were informed of the program "From the school or agency."
- 76% "Agree" or "Strongly Agree" the program is improved their child's reading skills.
- 79% "Agree" or "Strongly Agree" the program is helping their child's math skills.

Through partnerships and internal contributions, the financial contributions to RCCLC were \$286,927. Community partners have pledged money or in-kind contributions to help maintain the program. The RCCLC is in its second year of the current grant and has had success due in part to the numerous financial contributions.

Overall Commendations and Recommendations

RCCLC should once again be commended for a continuance of a well-attended second year program. With a goal of 250 regular attending students, the program far exceeded the targeted number of 250 by serving 308 regularly-attending students. The program's popularity was also showcased by a student waiting list, and survey results showing highly satisfied students, parents, and day teachers. RCCLC continues the Rabun County School System tradition of providing students an excellent education.

The following recommendations should be considered:

- Continue to encourage the completion of parent surveys; or, if surveys represent more than one student, please make a notation. With 196 surveys completed, this only represented 64% of the regularly attending 308 students.
- Increase professional learning opportunities throughout the school year.
- Provide additional professional learning for math and ELA strategies as funds become available.
