Dear Parent/Guardian:

The Onteora Central School District Athletic Department, consistent with District policy requires that when transportation is provided by the District, student-athletes shall be transported on District vehicles to and from away contests. Only parent/legal guardian requests, in the event of extenuating circumstances, will be honored for any deviation of this policy.

A parent or legal guardian of a student participating in an athletic event must provide written notice via the enclosed form within 48 hours of the contest in order to pick-up or have their child picked-up by another designated adult. This form is also available on the Onteora Athletic Website.

Parents/Legal Guardians of the child participating in an athletic contest may submit the Transportation Form one time per season if they will be picking up their own child throughout the season. If a parent or legal guardian at any point during the season requests for another adult to pick up their child, they must use the form each and every instance to obtain approval. Students of the Onteora School District may not drive themselves or other students to or from athletic contests.

We appreciate your cooperation as we continue to work to keep all of our students safe.
