Spring Branch ISD has not determined a specific number of Firms.
Is detail available on the various interior and exterior upgrades for existing campus facilities referenced in the bond information? No
Will that work primarily address building system MEP infrastructure replacement, perhaps accessibility compliance, deferred maintenance such as improvements to exterior envelopes, site utility upgrades, etc.?

 Page 4 of the RFQ reads: <u>"This Request for Qualifications also includes professional services to be contracted individually with the District such as civil</u>, geotechnical, testing labs and services, surveying, testing and balancing and commissioning services and any other additional services that may arise. Projects will include new construction, building renovations and additions, facility upgrades, new classroom furniture and athletic upgrades to include synthetic turf fields and any other projects that may arise." At the Pre-Submittal meeting it seemed from the Q&A that civil engineering services will be procured both as part of an Architect-Lead Team and individually. Could SBISD clarify this? Should a civil engineering firm submit both as part of an architecture team AND individually to cover all potential opportunities with the District as part of this Bond Program?

Question #6:	Can the district give any further details at this time about what projects might require civil engineering services individually?

Can it be left blank? Can the response be "TBD"?

Question #10:	Page 9, Tab 1 Item A indicates a letter of recommendation for each project example must be provided. As a typical letter is at least one page in length. Can a request be made for the District to exclude these letters from the 30-page limitation or delete the requirement for a letter?


Question #11:	Page 10, Tab 4 Item d. asks for a list of "typical consultant firms used" then notes that a re-evaluation of the "proposed" team will occur prior to a separate agreement. Is it the intent of the District for firms to partner in advance with firms and provide resumes, project experience, and general firm information or to only provide a list of firms that offer a best-value to the District? If a partnership is preferred, can the request be made to increase the total page limitation to accommodate the additional firm and team information?

There are conflicts between the two (10 days' notice of cancellation vs. 30 days' notice of cancellation; additional insured and waiver of subrogation requirements for professional liability).
