

# **EDISON PREPARATORY HIGH SCHOOL PARENT INVOLVEMENT PLAN 2018-2019**

**PART I: GENERAL EXPECTATIONS** Edison Preparatory High School agrees to implement the following statutory requirements:

Family Events, Music Programs (Vocal and instrumental), Drama Productions, Book Fair, PTSA meetings and events, Workshops/Presentation from Creoks offered on school campus, Volunteer opportunities, Sporting Events, Guest speakers, Back to School Night, Parent Conference dates, Parent weekly email Chain, PTSA and student newsletters, Power School (PARENT PORTAL) extended media center hours, Extracurricular activities and organizations.

Edison Preparatory School will:
