On the motion of Mr. Blanchard, seconded by Mr. Fuselier, and unanimously carried, the Board approved option 1 with regard to the Student and Athletic Insurance, which is to switch to Bollinger, premiums increase \$2,736 and benefits include:

- a) Accident Medical Maximum increases from \$25,000 to \$5,000,000
- b) Benefit Period increases from 1 year to 10 years
- c) Catastrophic Benefit now covers all students in addition to athletes and has no deductible, last year there was a \$25,000 deductible on the catastrophic benefit
