ANNOUNCEMENT OF VACANCY

The Board of Education of Joliet THSD 204, Joliet, Illinois is seeking qualified applicants for the position of Superintendent of Schools. The Board wishes to select a superintendent who will begin work on July 1, 2019.

It is anticipated that the total compensation package will be regionally competitive based on successful experience and education. It is expected that the initial contract will be for a multi-year period, as authorized by Illinois statutes.

CURRICULUM – District 204 curriculum has been developed through the collaborative efforts of our certified staff and aligned with the Illinois Learning Standards. As students successfully complete our recommended course sequence in the core academic subjects, they are provided with the knowledge and skills needed to be successful in their post-secondary institutions and/or career fields.

JTHS curriculum is delivered through a two-tiered academic system that includes college prep and honors. We understand that every career does not require a college education, but we also know that the world of work requires college-level knowledge and skills.

Programs of study have been developed which help students and parents select the most appropriate classes in their career interest pathway. In addition, we are increasing the number of dual credit and advanced placement courses so that our students will have an opportunity to earn college credit as they complete their high school coursework.

Our goal is to provide students with a rigorous and relevant academic foundation to ensure a successful transition from high school to post-secondary education or the workforce. SPECIAL SERVICES – In keeping with the vision and mission of the district, we are committed to providing services to students in the district who have individual and unique needs in a positive learning environment that partners with families and community.

Special Service programs include special education, home/hospital instruction, homeless education, and educational services at River Valley Detention Center. These programs provide students with instruction, social emotional supports, as well as other resources that enable students to acquire skills and knowledge that will prepare them to become lifelong learners and empower them to be successful responsible citizens of Joliet as well as in a global information driven society.

Joliet Township High School District 204 provides a free appropriate public education in the least restrictive environment and the necessary related services to all children with disabilities enrolled in the District, as required by the Individuals with Disabilities Act (IDEA).

For students eligible for services under IDEA, Joliet Township High School District 204 shall follow procedures for identification, evaluation, placement, and delivery of services to children with disabilities provided within the Illinois State Board of Education school code and regulations.

An Individual Education Plan (IEP) which includes transitional services and determines the least restrictive environment to meet the individual needs of the student, will be developed and implemented by the IEP team which includes, parents/guardians, students, and staff. In addition to providing academic supports, the district provides related services at the Central, West, and Alternate school campuses to further assist students' educational needs. Joliet Township District 204 provides a continuum of services based on the needs of the individual student with an IEP, which are determined by the IEP team.

TRANSPORTATION – In August 2011, The Joliet Township High School District 204 Transportation Department relocated to a new 148,000-square-foot facility located at 3901 Olympic Boulevard in Joliet. The centrally located facility provides improved training, office, and employee space; indoor and outdoor bus parking; and a new maintenance facility. Moving the Transportation Center to the new facility provided space for the Child Care Center and Alternate School students.

CAFETERIA PROGRAM – The cafeteria provides quality breakfast and lunch selections each day. Students pay \$2.90 for a full lunch meal and \$1.90 for a full breakfast. The district participates in the National School Lunch Program and is monitored by the Illinois State Board of Education and the Will County Health Department.

THE COMMUNITY

COLLEGES – The University of St. Francis has two campus locations within the City serving 3,700 students. Joliet Junior College operates two sites within the community. The Main Campus and the new Joliet City Center Campus both provide quality degree and vocational education to the area. Lewis University is also located within the Joliet Area at One University Parkway in Romeoville.

INDUSTRY – The business community is active and well represented. The Joliet Area Chamber of Commerce, Joliet City Center Partnership and Heritage Corridor Convention & Visitors Bureau all provide support of local business and promote the interests of Joliet. The city also offers robust sectors such as industry, logistics, transportation, and distribution centers led by major employers like Caterpillar, ExxonMobil Corporation, Amazon, and CenterPoint. In addition, residents take pleasure in the community's outstanding schools and higher learning facilities, two award-winning hospitals, affordable real estate, and excellent public services, which all come together to provide a high quality of life that is truly second-to-none in the Chicagoland area.

RETAIL – Joliet is home to a strong and diverse retail base including a major regional mall. Retail opportunities exist within numerous commercial corridors as infill sites and as vacant pads. Manufacturing and logistics continue to expand with Amazon, IKEA, Mars, Whirlpool, Saddle Creek Logistics, and others selecting Joliet as home.

MEDICAL – State-of-the-art, award-winning healthcare facilities located within Joliet and the surrounding area include Presence Saint Joseph Medical Center and Silver Cross Hospital.

CULTURAL/RECREATION – The city of Joliet and its culture are represented in many ways, including historic murals, mosaics, and statues that have been created by the Friends of the Community Public Art (FCPA) to increase the awareness of a community's rich historical and cultural heritage. FCPA has set an example in the City of Joliet and can help other communities who also wish to distinguish themselves through visual art.

Major attractions in Joliet include historic downtown architecture, the Rialto Theater, Harrah's Casino, Hollywood Casino, Joliet Slammers baseball at Silver Cross Field, NASCAR at Chicagoland Speedway, Joliet Historical Museum, Route 66 Visitors Center, Ironworks Park, Bicentennial Park, Autobahn Country Club, and four regional bicycle trails.

Joliet and the Will County Region are experiencing a continuation of the residential, commercial, and industrial growth that was interrupted during the great recession. Permit activity continues to accelerate bringing millions of dollars of private investment to Joliet. So much has been happening here over recent years, especially in the downtown city center, which has been transformed into an urban hub for entertainment, shopping, dining, working, and living. With such community-wide attractions including two casinos, three racetracks, a professional independent baseball team, and much more, Joliet has developed into a flourishing tourist destination.

PLACES OF WORSHIP – The Joliet area has a broad range of religious representation and places of worship.

FRATERNAL AND PROFESSIONAL ORGANIZATIONS – Joliet Township High School has over 600 community partnerships and/or volunteers that include members of fraternal and professional organizations. Annually in May, JTHS honors community partners at the Salute to Service Partnership Recognition Event.
