## NON-FOOD PROMOTIONAL BOOTH: REQUIREMENTS

- Maximum size of tent/canopy is 10' x 10'. Items must not protrude beyond this space.
- Location of canopy is at the discretion of Tournament of Bands, though every effort will be made to locate the booth in a mutually beneficial location.
- Setup and takedown must be by sponsoring company on Saturday only. Booths may be setup at 10 am or later.
- No selling of any kind. Free promotional items may be given out with the exception of food samples.
- Maximum number of workers per tent is three. Workers must check in at our Information table, wear the TOB lanyard at all times, and return it when they are done with their promotion.
- No advertising outside of the booth, such as calling to patrons, directing them to the booth, passing out flyers, etc.

## FOOD SELLING PROMOTIONAL BOOTH: REQUIREMENTS

- Maximum size of tent/canopy is 10' x 10'. Items must not protrude beyond this space.
- Location of canopy is at the discretion of Tournament of Bands, though every effort will be made to locate the booth in a mutually beneficial location.
- Setup and takedown must be by sponsoring company on Saturday only. Booths may be setup at 10 am or later.
- Food booths must pay for their canopy/tent's portion of the Santa Clara County Health Permit, or provide a copy of their *Annual Temporary Event Permit* issued by Santa Clara County and valid through 10/8/16.
- Food booth sponsors are responsible for meeting all the requirements for their canopy/tent to meet the SCC Health Permit regulations, including type of canopy/tent, hand washing requirements, etc. See <https://www.sccgov.org/sites/cpd/programs/TE/Pages/home.aspx> (Santa Clara County Temporary Events website) for more details.
- Only food listed below may be sold in the canopy/tent. Free promotional items may be given out with the exception of food samples, except for items listed below.
- Maximum number of workers per tent is three. Workers must check in at our Information table, wear the TOB lanyard at all times, and return it when they are done with their promotion.
- No advertising outside of the booth, such as calling to patrons, directing them to the booth, passing out flyers, etc.
- Sponsors can receive a free 1/4 page ad in our program in exchange for 5% of the profits of the operation.
