Charter School Petition for Aspire Benjamin Holt College Preparatory Academy 2

Elodia Lampkin, Assistant Superintendent, Elementary Education, presented the item for Board consideration. Lane Weiss, Superintendent, Aspire Charter Schools, and Jeff Palmquist, Principal, Benjamin Holt Academy, reviewed the mission and goals of the Aspire Charter schools. Proposed Revisions to Enrollment Preferences for all Aspire Charter Schools

Elodia Lampkin, Assistant Superintendent, Elementary Education, presented the item for Board consideration. Mr. Lane Weiss, Superintendent, Aspire Charter Schools, explained that the lottery for

school admittance is conducted electronically. Aspire is trying to access Senate Bill 740 funds to tie to the local demographics of the community to build a school that has the character of the community.

Ms. Cassel asked if Aspire was meeting their goal regarding low income student. Mr. Weiss noted a rate of 55% free and reduced is needed to gain SB 740 funds, and they are making progress towards that goal. Discussion ensued.

Mr. Neely voiced concern regarding a reduction in Average Daily Attendance without a corresponding decrease in expenses.

Communications

Comments from Student Representatives

Chez Demoulin, (filling in for Dominic Hummel), Lodi High School and Roman Romero, Ronald E. McNair High School, presented reports from their respective high schools.

Pat Patrick, President, Lodi Chamber of Commerce, noted he will speak under the Report section of the agenda.

Comments from Employee Group Representatives

Jeff Johnston, President, Lodi Education Association (LEA), extended an invitation to Board Members to attend the annual School Boards Dinner, hosted by California Teachers Association. Mr. Johnston spoke regarding the substitute teacher shortage, noting that trainings are valuable and important to our District so it is important to have substitute coverage so teachers can attend vital trainings.

John Hunt, President, Lodi Pupil Personnel Association (LPPA), extended appreciation from Lodi Pupil Personnel Association that a member of the Board attended the recent counselors' conference.

Comments from Board Members

Ms. Cassel stated she attended the Counselors' Conference and noted that Lodi Unified had more counselors in attendance than any other District in the county. She noted she will be sharing the information gathered at that conference with her colleagues. She attended the Film Camp Premiere on Monday evening, noting the students and the excitement of the evening. She complimented Liz Zastrow, Program Specialist, for her leadership and the staff at Needham West. She complimented Cathy Washer on the wonderful cupcakes provided for the event and to her husband, Brent Washer, for constructing the cupcake display. Ms. Cassel thanked Dawn Vetica for attending the event.

Mr. Womack attended the Audit Committee meeting, met with the Hmong Committee and attended the Film Camp Premiere. Mr. Womack provided information for students to attend Math Smart Tutoring in Stockton, which is free for sixth through twelfth graders.

Mr. Neely spoke regarding student testing scores, as a carryover from the November 3rd Board Meeting. He voiced concern about what the scores indicate, noting specific schools with low growth and a school with declining scores. Mr. Neely feels there is a systemic problem with the scores. He requested constant communication regarding corrective measures.

Mr. Nava, in reference to Mr. Neely's statements, cited the need to do research of the parent involvement/support at the lower performing schools. He cited the program at Live Oak Elementary School, as example of a way to garner parental support. Mr. Nava referenced the many exciting things that are happening in the District and congratulated students that have signed letters of intent to participate in sports and receive scholarships to various schools.

Reports

Facility Master Plan Process Update

Steve Newsom, Associate Project Director, LPA Architects, reviewed what the committee has completed thus far and previewed what is scheduled for the upcoming months.

Mr. Nava inquired as to when the funding will be looked at. Mr. Newsom noted there will be a prioritization process within the committee who will, in turn, bring a recommendation to the Board, who would then have the final prioritization.

Ms. Cassel asked about under and/or over utilization of school sites based on enrollment figures. Mr. Newsom noted the Facility Master Plan will show if a school is expected to go over capacity or fall below capacity for an extended period of time. The master plan document can be edited in the future after the original is complete, as it is a living document.

Projects for the Consideration of Funding Through the Entitlements for the 2015-16 One-time Funds for Outstanding Mandate Claims (\$14,162,187)

Dr. Washer presented a list of ideas for one-time funding as a starting point for Board discussion and consideration for possible action at the December Board Meeting. Several Board Members requested the topic be discussed at a Study Session. Dr. Talken noted he needed more information to make a decision, including more information on Instructional Technology dollars and additional information as to where the greatest needs exist. Mr. Hern explained that the list includes items that the District doesn't see any money for in the next three years. Mr. Heberle noted he is looking at the money going more in the lines of instruction to students.

Next Generation Science Standards (NGSS) and Science, Technology, Engineering and Mathematics (STEM) Report

Lisa Kotowski, Assistant Superintendent, Curriculum and Instruction, and Charalee Cunningham, Science Specialist, presented the report.

Mr. Neely voiced his opinion that STEM needs to be replaced by STEAM, which would incorporate art. Mr. Heberle inquired as to the pathways. Ms. Cunningham explained the pathways and how they build upon each other. Mr. Heberle spoke regarding a Science Standard Committee, K-12 and suggested looking into duplicating the STEM program currently being offered at Delta Sierra. Discussion ensued.
