

**Enochville Elementary School**  
**Title I Parent and Family Engagement Policy**  
**2018-2019**

We believe that the cooperative efforts of parents and educators are essential for the successful education of children. Continuous communication is needed for educators to act on the suggestions and concerns of parents, and for parents to provide support at home for the school's educational programs. These policies have been established in order to promote and ensure effective communication.

- Enochville is a Schoolwide Title I school. Therefore, all students at Enochville are considered Title I students, and all teachers are considered Title I teachers.
- An annual public meeting will be conducted on campus within the first twenty days of the school year to inform parents about the Title I program and about their rights as parents of Title I students.
- A Home-School- Agreement has been developed, which outlines for all parties involved the responsibilities needed to be carried out to ensure each student's success. The Agreement is to be signed by each student, the parent(s), the teacher, and the principal. Copies of these will be housed in classrooms, as well as a copy in each students take-home folder.
- Parents will be given reports periodically to inform them about their child's work and progress in the educational program. These reports may be in the form of notes, phone calls, conferences, electronic communications, weekly folders, schoology, or progress reports.
- Parents will be informed about special program events and activities through a newsletter, invitation, peachjar, and/or Connect-Ed message.
- Teachers will be available for conferences at the parents' requests. Teachers will also arrange conferences with parents as needed.
- Two or more workshops will be offered at the school for the purpose of training parents to promote the education of their children at home. The topics will originate from parent survey input. Periodically, additional parent information sessions will be provided by grade levels.
- The school's ESL teacher will provide assistance by having a prearranged translator available if needed to communicate with Spanish-speaking parents. When Spanish-speaking parents indicate that they will attend a parent workshop, efforts will be made to have a translator available when possible.
- At the end of the school year, parents will be given the opportunity to evaluate the effectiveness of the school's Title I program by completing a parent survey.
- Parents will be notified that they may, upon request, receive information regarding the professional qualifications of their child's teacher or paraprofessional in a timely manner.
- Parents are invited and encouraged to visit the school to review the School Improvement Plan and the Title I Plan. Copies of the plans are available in the office.
