1) Student Achievement

***Promote an exciting, challenging and supportive learning environment that actively engages all students.***

- **Implement initiatives and practices as outlined in the district Strategic Plan**
- **Periodic review and enhance curricular and extracurricular programs**
- **Increase interaction between district and community members who have skills that enhance student learning (artistic, historical, technical, environmental, etc.)**

2) Culture and Climate

**Reflect the distinct characteristics of our natural surroundings by prominently integrating the arts and environmental sciences in all schools' mainstream curriculum while concurrently striving for excellence in core subjects.**

a) Students

- Ensure district procedures create a safe, orderly environment (i.e. electronics, dress code consistency, district-wide building safety plans, etc.)
- At least one annual Board meeting with high school students

b) Community Outreach/Collaboration

- Provide information regularly to the local newspapers announcing school news, focusing on student achievement and district events

### **3) Human Resources**

*Support, retain and attract the highest quality staff to enhance student learning.*

- Recruit and retain quality staff to advance the vision and goals of the district. Review staff recruitment process. Update as necessary
- Identify and mentor district staff for future administrative positions
- Annually articulate goal-planning model for staff.
- Ensure that personnel are trained. Establish half-yearly review process
- Establish a procedure for frequently soliciting feedback from teaching and administrative staff with regard to district needs. This information will be compiled and distributed to the Board
- Prioritize health and wellness for students and staff.
  - Create annual plan for PE and Food Services, including input from district Health and Wellness Advisory Committee
- Establish exit interview process to analyze patterns why staff leave, and take required corrective action

### **4) Board Development**

*Encourage and support a democratic, professional governance team, and maintain collaborative relationships to support the district vision.*

*Utilize behaviors, practices and planning that protect and maximize the fiscal assets of the district, while encouraging the reduction of facility operating and maintenance costs.*

- Use 3-year average model to aid in formulating budget

- Student learning should be prioritized when looking at Budget reductions
- Analyze tax certiorari implications

- Establish rotating departmental budget review to insure effective use of funds matched with student learning

b) Maximize Revenues

- Review program reimbursements (i.e. EXCEL moneys, Medicaid reimbursement, BOCES co-services, etc.)

- To insure a minimum of 3 respondents for each RFP (Request For Proposal); seek quality bidders through advertising, and if specialized, through relevant associations
- Investigate the use of performance contracts and other resources where possible
- Complete contract negotiations as soon as possible
- Foster the use of alternative energy sources and practice energy conservation consistent with district Sustainability Policy #5651
- Employ local work forces, where possible, to support our communities consistent with district Sustainability Policy
- Explore avenues for reducing the burden of local school property taxes at the state level through alternative funding, while maintaining excellence in education
