Careers at Slough and Eton

At Slough and Eton, we are dedicated to providing a scheduled programme of impartial careers education and information, advice and guidance (CEIAG) for all students in Years 7-13.

Every student should look forward to a positive future through a carefully and thoroughly prepared careers programme.

Students are at the heart of what we do, as such, Slough and Eton places significant importance on the activities that students undertake to ensure progression in their learning and development, and to strengthen their motivation, aspirations and achievements at school.

Slough and Eton provides Careers' Education and Information in various ways, available to parents, carers and students to help them appreciate and choose the many academic and vocational choices they will make during their time at Slough and Eton that will help shape their futures.

Slough and Eon continually invests in maintaining a comprehensive careers library offering information on further education, higher education, apprenticeships and employment, as well as prospectuses from all the sixth form colleges in the local area and beyond. Careers information can also be found on the CEIAG display board.

Here at Slough and Eton we:

Have invested in the eCLIPS online careers resource as well as KUDOS online careers software, providing students with independent, impartial careers advice.



Set up Adviza individual meetings for students. The focus of these meetings is to enable students to discuss their interests and ideas and develop the skills they need to make decisions for their future.

Maintain a dedicated room for careers guidance interviews.

New Careers Statutory Guidance

Slough and Eton continues to strive to meet and exceed the DfE statutory guidance, including new requirements for school careers programmes, most of which are to be met by the end of 2020.

One of the foremost requirements is for all schools to have a policy for 'Provider Access'. The aim of this is to provide clarity as to how and when external organisations will be permitted access to Slough and Eton students to promote various other educational routes and training opportunities. Slough and Eton already works with a range of external organisations, but we are now reviewing our school careers policy so that it will include a section on provider access, and will publish our updated policy as soon as possible.

Gatsby Benchmarks - What are they?

Every young person needs high-quality career guidance to make informed decisions about their future. Good career guidance is a necessity for delivering technical education reforms and is a vehicle for social justice: those young people without social capital or home



support suffer most from poor career guidance. Yet, despite its importance, career guidance in English schools has often been criticized for being inadequate and patchy.

Against this background, in 2013 Gatsby commissioned Sir John Holman - Emeritus Professor of Chemistry at the University of York, senior education adviser and former headteacher - with setting out what career guidance in England would be like, were it good by international standards.

After six international visits, analysis of good practice in English schools and a comprehensive review of current literature, John wrote the, "The Good Career Guidance Report" which identifies a set of eight benchmarks that schools can use as a framework for improving their careers provision. These benchmarks have been well received by schools, government and a wide range of stakeholders.

The Baker Clause

Introduction

As part of our commitment to informing our students of the full range of learning and training pathways on offer to them, we are happy to consider requests from training, apprenticeship and vocational education providers to speak to students. This complies with the school's legal obligations under Section 42B of the Education Act 1997. Slough and Eton School also proactively seeks to build relationships with these partners as we plan our Careers Education, Information, Advice and Guidance (CEIAG) programme activity throughout the school year to ensure that providers have multiple opportunities to speak to students and their parents across years 7-13. The purpose of these relationships are to offer information on vocational, technical and apprenticeship qualifications and pathways.

Opportunities for access

A number of events, integrated into the school careers programme, will offer providers an opportunity to come into school to speak to students and/or their parents/careers. This may include school assemblies' employer and provider engagement events or opportunities to speak with students and parents on a one-to-one basis supporting GCSE, post 16 or post 18 option choices

Management of provider access requests

A provider wishing to request access should contact Gurdeep Sira on gurdeep.sira@slougheton.com with a minimum of 6 weeks' lead time. All requests will be considered on the basis of; staffing availability to support the activity, clashes with other planned activity, trips or visits, interruption to preparation for examinations or rooming and space availability to host the activity.

Premises and facilities

Slough and Eton School will make the main hall, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of their team.
