**Bus Behavior Rules for students attending American Heritage Summer Programs:**

Below is a list of rules that must be followed in order for your child(ren) to ride the bus to and from camp/school. We use this means to outline the basic responsibilities of your child(ren) while riding the bus. Campers/Students who violate these rules, pursuant to our agreement with American Heritage Summer Programs, will be referred to the Camp Director or Summer School Principal.

**ATTENTION: Each bus is equipped with video and audio recording devices. Your child(ren)'s image & voice may be recorded. By permitting your child(ren) to ride the bus, you are consenting to the recording of your child(ren)'s image & voice.**

***Campers/Students Are NOT ALLOWED to:***

- put arms, hands, head, or legs out of window
- use abusive or profane language/gestures directed toward fellow campers/students, C&L personnel or public at large
- throw objects inside the bus or out of the bus
- leave their seats while bus is in motion or without permission
- eat, drink, chew gum, use tobacco products, use alcohol, prescription drugs or controlled substance on the bus
- engage in nonconsensual touching, consensual inappropriate touching or any harassing behavior (physical or emotional)
- physically or verbally abuse the bus driver
- board or exit bus except at camper's scheduled stop and board or exit bus in a disorderly manner
- tamper with, damage, or deface C&L property (parents may be held financially responsible)

***Campers/Students Are EXPECTED to:***

- be on time at the designated loading zone or bus stop as applicable and go immediately to their seat and be seated
- wait until the bus is completely stopped before moving forward to enter the bus
- be absolutely silent at railway crossings
- sit in assigned seats and MUST wear their seatbelt (when available). Bus drivers will report those who refuse to buckle up.
- cross the street in FRONT of the bus after receiving the all clear from the driver (**NEVER Walk BEHIND the bus**)
- **OBEY** the bus driver

At the discretion of the Camp Director/Summer School Principal, camper/student bus privileges may be suspended for a period of time or completely. In such case, there will be no refund of fees. C&L Bus Company also retains the right in its sole discretion to impose suspension or termination of bus privileges.

Please discuss the importance of these safety rules with your child(ren).

***This form must be completed and returned to C&L before bus service can begin.***
