#### 3. School Climate Survey Report - Paul Pattavina

#### 7. Discussion regarding FY 17 budget [ATTACHMENT #3 & 4]

Dr. Graner explained that a \$262,000 cut needs to be made. Dr. Graner further explained cuts in transportation (\$330,000) and ECS totaling \$621,849. Overall, Dr. Graner estimates that Groton may lose 1.3 million dollars.

Dr. Graner noted that plans are being made to restructure the Central Office; the position of Director of Teaching and Learning will be eliminated and Ms. Austin will oversee Curriculum; Karen Bryer has requested to return to the classroom; the other coordinators will remain.

#### 8. Update regarding Magnet School Tuition Payments [ATTACHMENT #5]

Dr. Graner shared a comparison of enrollment trends for enrollments in the different schools that we transport students to and explained the tuition for each.

# Adopted FY 17 State Budget Impact on: Groton (Town)

On May 4, 2016, the General Assembly is expected to adopt the state budget adjustments for FY 17. Below are grant estimates for **Groton (Town)** for certain key programs.

Please note that the only estimate currently available for MRSA is an aggregate total. We do not know how much of that amount is Motor Vehicle Reimbursement, how much is Select PILOT, or how much is Sales Tax Sharing. Once we have those breakdowns, we will send them to you.
