Tobacco Free Campus Policy and Drug and Alcohol Free Campus Policy

Policy 1165 – Tobacco Free Campus Approval Date – February 2018 Category – Foundations and Basic Commitments Governance Accountably – Leadership Audience – Students, Employees, Volunteers and Families

Tobacco Free Campus

Student:

It shall be a violation of this policy for any student of Pine Lake Preparatory to possess, consume, display or sell any tobacco products, tobacco-related devices, electronic cigarettes or products that reasonably resemble tobacco or tobacco products at any time on school property or at off-campus, school-sponsored events.

Staff, Administrator, and Visitor:

It shall be a violation of this policy for any staff, administrator, or visitor of Pine Lake Preparatory to possess, consume, display or sell any tobacco products, tobacco-related devices, electronic cigarettes or products that reasonably resemble tobacco or tobacco products at any time on school property or at off-campus, school-sponsored events.

Definitions:

The term "tobacco product" means any product containing, made, or derived from tobacco that are intended for human consumption, whether chewed, smoked, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means. Examples include but not limited to, cigarettes; cigars; little cigars; dry snuff, moist snuff/chewing tobacco; snus; dissolvables; hookah; and blunt wraps.

The term "electronic cigarette" means any oral device that provides a vapor of liquid nicotine, lobelia, and/or other substance, and the use or inhalation of which simulates smoking. The term shall include any such devices, whether they are manufactured, distributed, marketed or sold as e-cigarettes, e-cigars, e-pipes, or under any other product name or descriptor.

The term "tobacco-related devices" means ashtrays, cigarette papers or pipes for smoking or any components, parts, or accessories of electronic cigarettes, including cartridges.

The term "school property" means all facilities and property, including land, whether owned, rented, or leased by Pine Lake Preparatory, and all vehicles/buses owned, leased, rented, contracted for, or controlled by Pine Lake Preparatory for use in transporting students, staff, or visitors.

Drug and Alcohol Free Campus

Pine Lake Preparatory is dedicated to maintaining a drug-free environment for students and employees, as well as any visitors.

- The use of drugs and/or alcohol by students is prohibited on school property and at all school-sponsored events.
- The use of drugs by employees or visitors is prohibited on school property and at all school-sponsored events.
- The use of alcohol by employees or visitors is prohibited on school property and at all school-sponsored events where students may be present.

Under the personal conduct disciplinary process, anyone reporting to work or school under the influence of drugs or alcohol on school property is subject to disciplinary action by the school and may be reported to the Mooresville Police Department.

It shall be a violation of this policy for any students, staff member, administrator, or visitor of Pine Lake Preparatory to use, consume, display, sell or be under the influence of any of the following substances:

- 1. Narcotic drugs;
- 2. Hallucinogenic drugs;
- 3. Amphetamines;
- 4. Barbiturates; marijuana or any other controlled substance;
- 5. Synthetic stimulants, such as MDPV and mephedrone (e.g., "bath salts"), and synthetic cannabinoids (e.g., "Spice," "K2");
- 6. Any alcoholic beverage, malt beverage, fortified or unfortified wine or other intoxicating liquor; or
- 7. Any chemicals, substances or products procured or used with the intention of bringing about a state of exhilaration or euphoria or of otherwise altering the student's mood or behavior.

Students also are prohibited from possessing, using, transmitting or selling drug paraphernalia or counterfeit (fake) drugs. Students may not participate in any way in the selling or transmitting of prohibited substances, regardless of whether the sale or transmission ultimately occurs on school property.

Possession or use of prescription and over-the-counter drugs is not in violation of this policy if such drugs are possessed and used in accordance with school policy and procedures (Policy #3240).

The term "school property" means all facilities and property, including land, whether owned, rented, or leased by Pine Lake Preparatory, and all vehicles/buses owned, leased, rented, contracted for, or controlled by Pine Lake Preparatory for use in transporting students, staff, or visitors.
