

## SELF-TRANSPORTATION RELEASE FORM ELMHURST COMMUNITY UNIT SCHOOL DISTRICT 205 SPONSORED ACTIVITY / CLUB / SPORTS

In its discretion, Elmhurst Community Unit School District may transport students to and/or from off-campus events and activities of clubs sponsored by the District. When such transportation is not provided, students and/or their parent(s)/guardian(s) are solely responsible for transporting students to and from such events and activities (referred to herein as "self-transportation") as a condition of the student being allowed to participate in an event or activity. **A student's parent/guardian must complete and return this form to York Athletic Office prior to self-transportation of the student to or from any athletic, club event or activity.**

By signing below, and in consideration for the opportunity for my student to participate in off-campus club events or activities, I certify and agree as follows:

1. That I am the student's parent/guardian.
2. That I assume full responsibility for the student's transportation to and from all off-campus events and activities for the club listed above and for the time frames listed above, unless the District provides transportation for an event or activity.
3. That I recognize and acknowledge that there are certain risks of physical injury to the student and/or third parties/bystanders when a student transports him/herself or is transported by a third party other than the District to an off-campus club event or activity, and that **I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my student, a third party, or I may sustain and/or cause through such self-transportation, or which in any way may result from such self-transportation. I agree to indemnify, defend, and hold harmless Elmhurst School District, including its Board of Education, individual Board members, representatives, agents, volunteers, employees, contractors, and assigns from any and all claims and costs (including attorney fees) resulting from injuries to person or property, including death, damages, and losses sustained by the student or a third party and arising out of, connected with, or in any way associated with the student's self-transportation to such an event or activity.**
4. That I agree to waive and relinquish all claims my student, our representatives or assigns, or I may have (or which may accrue to one or all of us) as a result of self-transportation to an off-campus club event or activity, and hereby fully release and forever discharge Elmhurst School District from any and all claims for injuries, damages or loss arising out of, connected with, or in any way associated with such self-transportation of my student.
5. I understand that my student must comply with the provisions of the Student Handbook and other rules of conduct established by the District while participating in club events and activities, including those that occur off campus and including during self-transportation to and from such events and activities. I have discussed that requirement with my student.
6. It is the express intent of the undersigned that this waiver and release shall bind the members of their family, their spouse, their heirs, assigns, and personal representatives and shall be deemed as a release, waiver, discharge, and covenant not to sue Elmhurst School District.
7. If any term, covenant, condition, or provision of this waiver and release is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions shall remain in full force and effect and shall in no way be affected, impaired, or invalidated.
