District Budget Meeting

The meeting was called to order at 7:30 p.m. by Chairman Witkins. Beth Jones read the call of the meeting as follows:

Notice is hereby given of the Annual Budget Meeting and Vote for the Regional School District No. 18 to be held at Regional School District No. 18, Lyme-Old Lyme Middle School Auditorium, 53 Lyme Street, Old Lyme, Connecticut at 7:30 p.m. on Monday, May 4, 2015 to act upon the following:

1. To adopt a budget of \$32,547,409 for the fiscal year beginning July 1, 2015 through June 30, 2016 as recommended by the Regional School Board.
2. To conduct such other business as may properly come before the meeting.

By vote of the Regional School District No. 18 Board of Education, the vote on item number 1 shall be by check off and paper ballots in the Town of Lyme and Old Lyme on May 5, 2015 between the hours of 6:00 a.m. to 8:00 p.m. pursuant to Section 7-7 of the Connecticut General Statutes.

Voting will take place at the following locations: in the Town of Lyme, at the Hamburg Fire Station, Route 156, Lyme, Connecticut and in the Town of Old Lyme, at the Cross Lane Fire House, Cross Lane, Old Lyme, Connecticut.

Mr. Fuchs made a motion, which was seconded by Mrs. Wilczynski, to nominate Lynn Warren as the moderator of the meeting. There were no further nominations. The vote on the motion was unanimously in favor.
