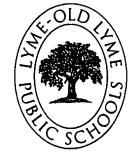

I. Call to Order

The meeting was called to order at 6:30 p.m. by Chairwoman Roche. The Pledge of Allegiance was recited.

II. Approval of Minutes

1. Regular Meeting of August 3, 2016

MOTION: Mrs. Winchell made a motion, which was seconded by Dr. Goulding, to approve the minutes of the Regular Meeting of August 3, 2016 as presented.

VOTE: the Board voted unanimously in favor of the motion.

III. Visitors

1. Recognition of Retirees

The Board recognized two retirees: Joanie Bonvicin who served the district as the Middle School secretary for 44 years and Nancy Johnston, Director of Special Services, who served in that capacity since 2008.

2. Grant Presentation by Frontier Communications

Representatives from Frontier Communications were present at the meeting and formally presented the PEG Grant Award in the amount of \$12,287 to the District. Frontier Communications made grants available to local community access television stations and school districts to improve technology and the classroom learning experience as part of the Public Educational and Government Programming (PEG) Grant Program.

The \$12,287 funding will be used to purchase:

3. Public Comment

There was no public comment.

4. Report from Student Representatives

Madeline Zrenda and Matthew McCarthy reported on the following activities taking place at the schools:

At LOLHS: The high school reported a great opening to the 2016-2017 school year which began with the annual freshmen picnic where 135 new students and their families were welcomed to the school. All students were issued a new laptop and received training on its care and use. Students were introduced to the learning management system (Campus) that they will use to interface with their teachers. Fall sports teams have been practicing for the last two weeks and will begin play this weekend.

At LOLMS: The middle school conducted a successful Open House the day before school started and welcomed students. Thanks were extended to the Lymes' Youth Service Bureau for providing an ice cream social immediately after the Open House. The first middle school newsletter was sent to all parents on Friday, September 2, and contained an "In the Classroom" section identifying new staff. Every month the newsletter will highlight a classroom activity/unit to help inform parents of the work students are doing in classrooms. Back to School Night is Thursday, September 8. Thanks were extended to the PTO for making it possible for the students to attend the Bushy Hill trip for 6th graders. EMPOWER, a team building organization, will be coming to the LOLMS campus to work with each grade level.

At Lyme Consolidated School: Students were excited to return from their summer break. Lyme School has 31 new kindergarten students and 19 new students that entered in grades 1-5. The total enrollment is now at 201 students. The building looked great thanks to custodians Jodi Lenz, Rich Bannister and Frank Ferris. The student paint crew did a fabulous job once again this summer. PTO has a very busy September with their first meeting on Thursday, September 8, at 9:00 in the morning. The family picnic will be held on September 16 from 5:30 to 7:00 p.m., Back to School Night will be held on September 22 from 6:30 to 8:00 p.m., and school pictures will be taken on September 27.

At Mile Creek School: Mile Creek students, staff and parents had a very successful start to the new school year. Students, kindergarten through grade 5, eagerly entered their classrooms and settled into the school routines without skipping a beat. Thanks were extended to the PTO for establishing a warm and welcoming group of parent greeters for the youngest students for the first five days of school. The Mile Creek PTO is hosting a Back-to-School Picnic on Friday, September 9. Mile Creek School will proudly host its Parents' Night on Thursday, September 29. Dr. Downes and the Mile Creek Staff extended thanks to the custodial, maintenance and the summer college crew for the amazing job they did cleaning, painting and making the school shine.

In the Preschool Program: With many happy smiles and just a few tears, the preschoolers have settled in to the new school year. The themes for September are 'Welcome to School,' 'All About Me,' 'Family/Culture,' and 'Apples.' The literature selections for September include: We Are All Alike and We Are All Different. The preschool team will be holding an Open House for parents and guardians on Tuesday, September 27.

IV. Administrative Reports

1. Superintendent's Report

Mr. Neviaser reviewed the September personnel report which reflected several new hires.

Mr. Neviaser reviewed the September 2016 enrollment report which reflected an in-house enrollment of 1,302 - a decrease of 20 students from June 2016. Mr. Neviaser reviewed data on the number comparisons as each grade moved up one grade from June to September which reflected a slight increase in almost every grade. The attrition in overall enrollment is reflected in the number of students graduating and the low kindergarten enrollments that the district is now experiencing.

Mr. Neviaser reported on the opening of the 2016-2017 school year including the Convocation and professional development days that occurred on August 29 and 30.

Mr. Neviaser reminded the Board to contact Jeanne DeLaura if they were going to attend the CABE/CAPSS Convention scheduled for November 18-19, 2016.

2. Business Manager's Report

Mrs. McCalla reviewed the Executive Budget Summary noting that comparison year over year shows a

slight increase, at this point, mostly due to time and payment of invoices. She noted that it was very early in the fiscal year for any trends to reveal themselves.

Also of note:

Employee Benefits – variance due to timing/payment of invoices.

Administrative Services – reclassification of technology spending.

Mrs. McCalla reviewed the Contingency Maintenance Report. The remaining balance is \$127,521 with the majority of monies encumbered to address the main campus water situation. At this time, the monies are an estimate and will fluctuate based upon invoiced amounts.

V. Educational Presentation

1. SAT and SBAC Report

Dr. Beth Borden, Director of Curriculum, gave a PowerPoint presentation on the results of the SAT and SBAC tests administered in the spring of 2016. Her report included background information on each test, the results of the tests, and plans for improvements. A copy of her presentation is attached to these minutes for informational purposes.

Questions and comments followed the presentation and were addressed by Dr. Borden, the Superintendent and other administrators. The following questions and comments were discussed and addressed on the testing report: effect on scores with the implementation of every student taking the SAT test; comparisons of scores with those districts who scored in the top ten percentile; historical testing data; nationwide comparisons of SAT scores; teaching to the test; encouraging students to take the SAT test more than once; SAT prep classes; and researching strategies used by top performing schools.

VI. Chairman & Board Report

Mrs. Roche reported on information she received from CABE on Board self-evaluation.

Mrs. Roche asked all Board members to make an effort to attend committee meetings; she also recommended that committee chairs consider scheduling committee meetings on a regular basis.

VII. New Business

1. District Goals for 2016-2017

Mr. Neviaser reviewed specific yearly goals for the district as follows:

Teaching and Learning

- 1. Analyze and identify areas of need based on multiple performance indicators including, but not limited to, SAT and SBAC results.
- 2. Infuse targeted differentiated practices into a growth mindset culture within each school and classroom.
- 3. Integrate the authentic use of technology in all content areas across all grade levels.

Human Resources

1. Refine teacher and administrator evaluation goals and plans.

- 2. Provide focused professional development based on district data, curriculum goals, and state mandates.
- 3. Maximize alignment of schedules and personnel to best utilize district resources PK-12.
- 4. Monitor, assess, and develop staff proficiency in technology.

Community

- 1. Further access community based resources to support mentoring, vocational, transitional, and educational opportunities.
- 2. Implement a comprehensive marketing strategy through the use of traditional/technological methods.

Facilities/ Technology

- 1. Establish and maintain a framework of support to train students and staff in the effective management and utilization of technology tools necessary to meet district expectations for skills and application in a digital learning environment.
- 2. Monitor facility needs to establish appropriate budget priorities.

The Board discussed the growth mindset educational initiative spearheaded by Carol Dweck and the related presentation that was given to all staff at Convocation.

MOTION: Mrs. Linderman made a motion, which was seconded by Mrs. Wilczynski, to approve the District Goals for 2016-2017 as presented.

VOTE: the Board voted unanimously in favor of the motion.

2. D2 Media Solutions Proposal

Mr. Neviaser explained that as a part of the district's marketing campaign, he and Olwen Logan, Marketing Consultant, have been meeting with representatives from D2 Media Solutions (a subsidiary of *The Day* newspaper) to contract them for a variety of services from September 2016 to February 2017. He reviewed the contract as well as the decision-making process. The cost is \$22,210. Board approval and a waiver of the bidding requirements is necessary. A copy of the contract is attached to these minutes for informational purposes.

The Board reviewed the proposal and asked pertinent questions with an emphasis on targeting and retaining the Lyme-Old Lyme student population.

MOTION: Mr. Cushman made a motion, which was seconded by Dr. Goulding, to waive the bidding requirements for contracting a company for the district's marketing campaign.

VOTE: the Board voted unanimously in favor of the motion.

MOTION: Mrs. Lucas Edson made a motion, which was seconded by Mrs. Linderman, to approve the contract with D2 Media Solutions for a total of \$22,210.

VOTE: the Board voted unanimously in favor of the motion.

3. Facilities Truck Lease Purchase

John Rhodes, Director of Facilities and Technology, provided the following background information on this agenda item: as part of the annual facilities equipment purchase program, the school district has publically advertised for a replacement truck. The current truck being replaced was purchased in 2003. The proposed replacement truck is a Ford F450 equipped with a snow plow, sander and stake body dump. The plan is to continue to operate the 2003 and 2013 trucks along with the new truck which will facilitate grounds work, summer projects, support use by both the crew team and techno ticks for remote events and reduce maintenance staff use of their personal vehicles for district business. During the period when the maintenance staff will operate three trucks, they will evaluate whether operating three trucks is a more effective facilities operational model.

This truck is within budget and is being financed using a municipal vehicle lease agreement. These agreements are based on an APR of 5.45% and a \$1.00 purchase price at the end of the three-year term.

Questions were posed by the Board on interest rates and the uses for the truck.

MOTION: Dr. Goulding made a motion, which was seconded by Mrs. Linderman, to award Shaker Family Ford the lease/purchase agreement for the facilities truck including plow and sander for three annual payments of \$21,803.79.

VOTE: the Board voted unanimously in favor of the motion.

4. Regulations for Policy 2420 Enrollment of Nonresident Students

The Superintendent and Diane Linderman, Policy Chair, reviewed regulations which would become part of the tuition student Policy 2420 Enrollment of Nonresident Students. The regulations are detailed below:

The Lyme/Old Lyme Board of Education has established separate tuition fees for the following classifications of nonresident students who have been approved by the Lyme/Old Lyme Board of Education to attend Regional School District 18. This fee structure is applicable only when there are established and available in-house programs provided at the school which the student will attend that will meet the needs of the student, provided that additional costs do not incur to the district, and that Regional School District 18 shall not be required to add additional classes or new programs to accommodate the needs of a nonresident student or when the acceptance of the student will not place a hardship on the resources or finances of the school district. Should the fee structure not apply due to the aforementioned circumstances, the Lyme/Old

Lyme Board of Education reserves the right to adjust tuition fees for individual students to accommodate hardships created by the attendance of said student in Regional School District 18.

- A) Regular education students \$19,400
- B) Special education students \$19,400
- C) Students attending under Attendance Agreements (unless a multiple-year agreement to provide education facilities is entered into with another Board of Education) \$19,400
- D) Biological or adopted children of current staff members (50%)-\$9,700
- E) Biological or adopted children of active military parents (80%)-\$15,520
- F) Foreign students attending under an F-1 visa as required by SEVIS (150%) \$29,100
- G) Multiple students from the same family attending together will be required to pay the following amounts:

```
1<sup>st</sup> child— 100% of tuition fee
2<sup>nd</sup> child— 75% of tuition fee
3<sup>rd</sup> child— 50% of tuition fee
```

The Board wordsmithed the regulations and asked that the wording "biological or adopted" be removed from inclusion in the regulations. They also asked that the Unions have a buy-in on the regulations.

It was confirmed that these regulations, if approved, would be retroactive to the beginning of the 2016-2017 school year.

MOTION: Mr. Cushman made a motion, which was seconded by Dr. Goulding, to approve the regulations for Policy 2420 Enrollment of Nonresident Students with inclusion of editorial comments as well as running it by the unions for concurrence.

VOTE: the Board voted unanimously in favor of the motion.

VIII. Old Business

1. Student Discipline Policy Update

This is a second reading of this policy update. The Board wordsmithed the policy and made several minor adjustments.

MOTION: Mrs. Lucas Edson made a motion, which was seconded by Dr. Goulding, to approve Policy 2200 Suspension/Expulsion/Exclusion/Removal as amended.

VOTE: the Board voted unanimously in favor of the motion.

2. Closing of LOLHS Project

The district is still waiting for the final change order from the State so there is no action required on this agenda item.

There was no need for an executive session.

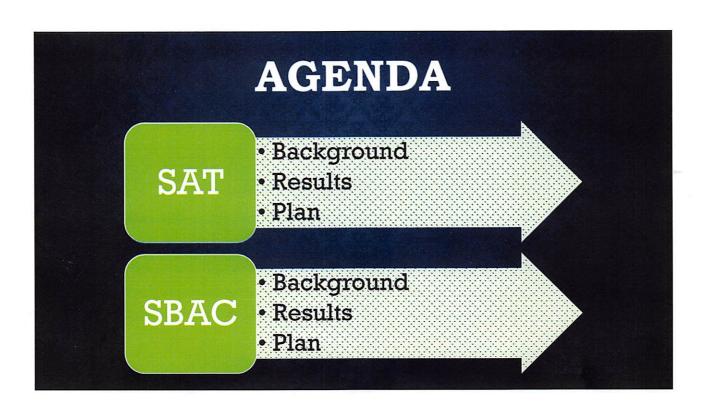

Overview

Lyme Old Lyme Public Schools faces a challenge of many school systems in CT – Retaining and Recruiting students to the school system.

Factors exacerbating this challenge include:

- Families moving out of the area to more business friendly states
- An abundance of options for primary education (magnet schools, private schools)

While these challenges are real and immediate, Lyme Old Lyme has advantages that no other schools in the region can claim:

- Ranked #5 in News Week
- Ranked #8 in US News and World Report
- Rowing Program
- · Nationally Recognized Robotics Program
- · Band and Choir

Tuition to out of system students is \$19,000 which makes it competitive with private schools in the region.

The purpose of the campaign proposed below is to accomplish the following:

- Put the school system on the top of minds of residents of the town and region
- Retain students already in the school system
- Recruit students from other systems at full tuition
- Recruit students who have left the school system for magnet or private school options
- Help lure new residents to the town who are looking for excellence in schools
