PARENT/GUARDIAN CONSENT FORM AND LIABILITY WAIVER

PERMISSION AND CONSENT - I, _____, certify that I am the parent and/or legal guardian of the student named above (hereafter "My Child"). I also certify that I am legally competent to make decisions for and on behalf of My Child. I further certify that I have, of my own free will, permitted My Child to participate in the athletic and/or off-campus activity (hereafter the "Activity") to which this consent and liability waiver applies. Specifically, the "Activity" refers to any team sport, local and/or remote location field trip, and such other Eton School sponsored activities my child voluntarily elects to participate in during the school year.

ASSUMPTION OF RISK - In granting the permission to My Child to participate in the Activity, I fully and expressly understand that the Activity may involve off-campus travel and that the Activity and off-campus travel present risks to My Child both serious and minor, including but not limited to property loss/damage, head and other injuries (including concussion), loss of sight, broken bones, brain damage, paralysis, other serious bodily and emotional injuries, loss of future earnings, loss of enjoyment of life, and death.

I further recognize, understand and agree that Eton School, Eton School Foundation, its members of the Board of Trustees, officers, faculty, employees, agents, volunteers, representatives, and such other person or group of persons associated with the Activity (collectively "Eton Personnel") assume no responsibility for any liability, damage or injury that may be caused by My Child's negligence or willful acts committed prior to, during or after participation in the Activity, or for any liability, damage or injury caused by the intentional or negligent acts or omissions of any other participant or group of participants in the Activity, or caused by any other person or group of persons.

IMPLIED AND EXPRESSED CONSENT FOR CARE – In the event of My Child's injury resulting from the participation in the Activity I expressly authorize Eton Personnel to seek medical care or such other cares from medical doctors and/or such other trained first responder person for and on behalf of My Child. In seeking such cares, I expressly release Eton Personnel from any and all liability for injuries, damages, including, but not limited to, financial liabilities.

PHYSICAL CONDITION AND INSURANCE – I attest that My Child is physically capable of participating in the Activity and has no known health restrictions that might jeopardize her/his safety or health or the safety or health of others during the participation in the Activity. My Child and I accept the responsibility to be informed, to take precautions to protect against risks, to behave prudently, to conduct ourselves in a safe manner and to read and abide by all reasonably available sources of information about the Activity.

WAIVER AND RELEASE AND COVENANT NOT TO SUE: I agree to release, hold harmless and indemnify Eton Personnel from all claims for any injury or damage resulting from any cause which arises out of My Child's participation in or travel to and from the Activity, including, but not limited to negligence by Eton Personnel, by My Child, or by another participant on the trip. This release is binding as to any other persons, including family members, heirs and executors. I agree not to sue Eton Personnel for injury or losses sustained by My Child, even if such injury or loss arose from the negligence of Eton Personnel. This release does not apply to gross negligent or intentional acts.

INDEMNIFICATION: I accept full responsibility for all medical expenses and claims incurred by Eton Personnel as a result of My Child's participation in or travel to/from the location in which the Activity takes place. I agree to indemnify and hold harmless Eton Personnel for any claims made by anyone arising from or relating to My Child's involvement in the Activities, except claims arising from Eton Personnel's gross negligence or intentional acts.
