I understand I am responsible for the above named student's transportation home at the conclusion of this event.

I, the legal aged student/parent/legal guardian of the above named student, understand that by the nature of the **Senior Blast Trip to Sleeping Lady Mountain Resort in Leavenworth, WA.**, that there will be times when it is not possible for The Bear Creek School or its employees or volunteers to supervise the above named student at this event. I understand that there may be unsupervised time when the above named student will be engaging in snow/winter activities, or at other places where direct supervision is difficult or impossible. I, the legal aged student/parent/legal guardian of the above named student, recognize that snow/winter activities are hazardous and dangerous activities with inherent risks. I recognize that such risks can lead to serious injury or death. The above named student has voluntarily made a choice to participate in this activity and expressly assume and accept the risks inherent in the activity. By signing below, I, the legal aged student/parent/legal guardian of the above named student, accept the responsibility to be informed, to behave prudently, act in a safe manner, and to read and abide by all reasonably available sources of information about the activity.

I, the legal aged student/parent/legal guardian of the above named student, agree to release, hold harmless, and indemnify The Bear Creek School and its employees, trustees, agents, contractors, officers or other representatives from all claims for any injury or damage resulting from any cause, including negligence, which arise out of participation in or travel to and from this activity. This Release is binding as to any other persons, including family members, heirs and executors. This Release does not apply to gross negligence or intentional acts.
