



# Lemont High School District 210 Facility Usage Rental Categories



## **CLASS I - No Charges**

This category includes: all Lemont High School District 210-approved student organizations; Lemont High School alumni organizations; employee staff organizations; organizations directly affiliated with Lemont High School; and all public schools located within District 210's geographical boundaries. **Examples of Class I organizations include:** Lemont High School Blue & Gold Backers, Lemont High School Educational Foundation, Lemont Band Parents Association, Lemont High School Alumni Association, Illinois High School Association, South Suburban Conference, Lemont-Bromberek School District 113A, among others.

## **CLASS II - Personnel Charges Only (includes custodial or technical assistance)**

This category includes groups supported by local taxes that wish to use a District 210 facility outside of normal building usage hours, as well as organizations that have a reciprocal intergovernmental agreement with District 210. **Examples of Class II organizations include:** Lemont Police Department, Lemont Fire Department, Lemont Park District, among others.

## **CLASS III - Personnel, Equipment and Facility Charges**

This category includes: community groups based within District 210's boundaries whose purposes in some degree parallel those of the schools and are supported by voluntary contributions; non-profit private schools located within District 210's boundaries and their affiliated organizations, colleges or universities; and groups who will utilize District 210's facilities for non-profit, religious, charitable, philanthropic, civic, or other non-commercial, non-personal use. Class III organizations may not charge admission or a fee to attend an event at a District 210 facility. **Examples of Class III organizations include:** Lemont Little League, Lemont Bears, Lemont Hornets, Lemont Indians, Lemont Lacrosse, Rotary Club of Lemont-Homer Glen, Lemont Junior Woman's Club, among others.

## **CLASS IV - Personnel, Equipment and Rated Facility Charges (facility fee includes energy charge)**

This category includes Class III organizations that charge admission or a fee to attend their events.

## **CLASS V - Personnel, Equipment and Rated Facility Charges**

This category includes for-profit groups based outside District 210's boundaries whose profits are used for the advancement of that group.

## **CLASS VI - Personnel, Equipment and Rated Facility Charges**

This category includes for-profit groups based outside District 210's boundaries whose profits are used for the personal gain of individual citizens. **Examples of Class VI organizations include:** a Home Show, among others.

## **PLEASE NOTE:**

- Lemont High School District 210 determines the availability of its facilities and any charges assessed to organizations applying to use those facilities. District 210 also determines an organization's class, and whether it is a community group based on the organization's location and its membership.
- Non-profit organizations (Class I, II, III or IV) must maintain and show proof of tax-free status as defined by state and federal regulations.
- District 210's Facility Usage Hours include:
  - Athletic Areas, Weekdays: 7:30-9:30 p.m.
  - Non-Athletic Areas, Weekdays: 3-9:30 p.m.
  - Saturdays: 8 a.m.-4 p.m.
  - Sundays: Facilities are unavailable

***Please note the Performing Arts Center may be available for use on days and times other than those listed above.***

- Lemont High School District 210 facilities are unavailable for rental on the following dates: New Year's Day, Martin Luther King, Jr.'s Birthday (observed), Presidents' Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day, Friday after Thanksgiving, Christmas Eve, Christmas Day, New Year's Eve
