It is anticipated that each of the schools will have several people who will be able to upload photos, content, and other information to the site; with perhaps a smaller number of people being given publishing rights.
- 4.2 Brief discussion of ways the committee might communicate with a wide range of audiences prior to the budget vote then ensued. Through a combination of social media, traditional print media, the new website, radio, and targeted marketing materials, the committee will look for ways to let voters know how their money is being spent; and the positive results we are seeing among our student population. It was agreed that the Barre Schools do an outstanding job providing numerous learning and growth opportunities for students, and we need to get that story out to the voters.

4.3 The balance of the meeting was spent discussing the Barre Education Coalition; its purpose; its potential make up; and specific individuals who will be asked to either consider joining, or recommend others who may wish to participate. The committee has scheduled a meeting with Coalition members and Public Agenda on October 25<sup>th</sup> to begin the process of explaining Site Councils; how they work; and how they can be effective communications tools for sharing concerns at the school, community, and board level.
