3. Update on proficiency-based learning and reporting

Brenda presented a slide show on proficiency-based learning (PBL) and reporting. (Slides are posted with these minutes.) It's important to note that the basis of this work is in Vermont statute and Rule 2000 as passed by the State Board of Education.

During the presentation, discussion ensued on how different PBL is from how education has traditionally been delivered. This includes linkage between PBL and flexible pathways: With the

expectation that all students must demonstrate proficiency, it will be important for students to have choice in how they do so. The slides lay out the five-year schedule for implementation of PBL and proficiency-based graduation requirements.

Brenda emphasized that there will be a great deal of support for students in achieving proficiency.

Brenda diverged from the slide deck to display some of the state's sample graduation proficiencies. In that connection, Brenda described how Spaulding teachers identified the key standards on which proficiency *must* be shown.
