

**MOORESVILLE GRADED SCHOOL DISTRICT BOARD OF EDUCATION
Called Meeting, Friday, July 26 2018, 9:00 a.m.**

The Board of Education of the Mooresville Graded School District met in duly noticed called session on Thursday, July 26, 2018, at Mooresville Intermediate School, 1438 Coddle Creek Hwy, Mooresville, NC.

Present were Mr. Roger Hyatt, Chairman; Mr. Greg Whitfield, Vice Chairman; Dr. Debbie Marsh; Mr. Leon Pridgen (by phone); and Mrs. Kerry Pennell.
