GREETINGS FROM OUR PRESIDENT









With each new Annual Report, I am reminded of what a unique institution Fuqua School really is. From its student-centered environment to the breadth of its programs, Fuqua stands as an example of what can be accomplished through the efforts of a talented faculty and staff, dedicated Board of Directors, supportive parent community, and steadfast contributors - all of whom share in the School's many successes and achievements.

Our students shine!

We are proud of our students' many accomplishments! First and foremost, the graduating class of 2013, comprised of 39 students, was offered collectively over \$5.2 million in academic scholarships to various colleges and universities, exceeding the amount offered any previous class. Eighth grader, Carson Johnson, participated as a semifinalist in the 2013 Virginia National Geographic Bee, and two seniors, Pranay Bonagiri and Caroline Wiles, were named *Commended Students* in the 2013 National Merit Scholarship Program, placing them among the top five percent of more than 105 million students who entered the competition.

Our students continued to play key leadership roles in Virginia's Model General Assembly (MGA) in which over 470 students from 40 schools across Virginia participate. Caroline Wiles was elected House Speaker Pro Tempore, and three students served in appointed positions: Tara Bauer as Clerk of the Senate; Heather Hicks as Chairwoman of the Education Committee in the Senate; Buck Wellman as Sergeant at Arms in the Senate. Whitney Forlines was elected to serve as the 2014 MGA Lieutenant Governor/President of the Senate, the second highest ranking office in the state government.

As part of her honors independent study on leadership, Fuqua senior, Emmalee Klein, planned and implemented a *Leadership Summit on the Hill* in collaboration with Hampden-Sydney College. Students from nine area public and private schools attended this impressive event. Our Battle of the Brains team qualified for the fourth straight year to compete as one of thirty-six teams in the televised academic tournament, defeating Hermitage High School, which enrolls approximately 2,000 students.

Strategic planning: Developing boundless individual potential

In November, we embarked on the development of a new long-range strategic plan. All faculty and staff participated in a retreat held at Longwood University to begin the process with emphasis on identifying key strategic priorities, followed by a Board of Directors planning session in January. Both meetings provided time to discuss strengths, challenges, and issues vital to ensuring that Fuqua School continues to offer the highest quality education possible and helped lay the framework for the School's future direction.

International program

Fugua School places high priority on exposing students to other cultures. A



primary avenue has been our foreign exchange program whereby students from other countries spend a year at Fuqua School. We have been fortunate to host students from countries ranging from Holland to Taiwan, all of whom deeply enriched our program.

In 2012, we expanded our global focus by entering into a partnership with The Cambridge Institute of International Education, an organization located in Boston dedicated to promoting cultural exchanges. Through this program, international students enroll at Fuqua for up to four years with the hope of entering an American University following graduation. We anticipate that this expanded program will provide the opportunity for our international students to become more actively involved in the life of the school.


"Lights Go On" project

Thanks to the generous support of several donors and the expertise and tireless efforts of Mr. Jerry O'Connor, the sound and lighting systems in Gilmer Gymnasium have been renovated. Mr. O'Connor's expertise stems from his work at Madison Square Garden and other production locations and proved to be invaluable to this exciting project.

Several of our old lights were salvaged and refurbished with today's technology, and additional new lights and a light board were purchased. Lights for the stage, "orchestra" area, and center court are now available. The new sound system offers "surround sound" which dramatically improves our former capacity. Microphones -cordless, lavaliere, choir - were purchased as part of the system. Two screens were installed for use in multi-media productions. One screen is rear projection which enables pictures and videos to be shown behind the students who are performing on stage. A larger screen was installed at the front of the stage for use with a new state-of-the art projector mounted to the ceiling.

The possibilities this project presents are endless! From band performances to theatre productions to guest speakers, we can now truly showcase the talents of our students and dramatically expand the quality of our programs and special events.

These are but a few highlights of the 2012-2013 academic year. They only touch upon the many accomplishments of our wonderful students and the unique opportunities Fuqua School offers throughout the year. We extend our deepest appreciation to the many supporters who believe strongly in our mission to develop the "boundless individual potential" that lies within each student, making it possible for us to provide the kind of education that will enable our graduates to pursue their dreams.

The only gift too small is no gift at all.



Fuqua School's tuition covers only 67% of the cost of educating its students; therefore, the tuition of every Fuqua School student is supplemented.


