1. Holmdel 2020 (Referendum):

- **a.** <u>Door Replacement (Indian Hill & Village):</u> *update since last month*, Some of the Closeout Documentation has been received. Upon receipt of all documentation, satisfactory to all parties, the project will be closed out formally.
- **b.** Gym HVAC project (Satz, Indian Hill old & Village old): update since last month. Closeout Documents have been provided to the architect and are being reviewed for completeness and then closed out formally.
- **c.** <u>Roggy Field Stadium Lighting:</u> *update since last month.* Closeout Documents have been provided to the architect and are being reviewed for completeness and then closed out formally.
- **d.** <u>Roofing Replacement:</u> *update since last month.* Closeout Documents have been provided to the architect and are being reviewed for completeness and then closed out formally.
