BE IT RESOLVED by the School Board of Independent School District No. 272 (Eden Prairie Schools) (the "District"), as follows:

1. It is hereby found, determined and declared that the general and special elections of the voters of the District held on November 6, 2018, were in all respects duly and legally called and held.
2. As specified in the attached Abstract (Exhibit A) and Return of Votes Cast, a total of 36,587 voters of the district voted at said general election on the election of one (1) school board members for one (1) year term vacancy on the board caused by a resignation of term on the first Monday in January next following the general election as follows:

3. Crandall, having received the highest number of votes, is elected to one (1) year term beginning on the first Monday in January, 2019.
