#### **THE SANDRA AND R. MICHAEL ALLEN ENDOWMENT**

The Allen Endowment was established in the fall of 2009 by Sandra and R. Michael Allen in grateful recognition to Saint Xavier High School and its efforts to develop young men to succeed in college and beyond. This endowment provides support for Saint Xavier's need-based tuition assistance program and offers the opportunity for a student to benefit from a St. X education.

#### **THE BROTHER RICHARD A. ANGAROLA, C.F.X. SCHOLARSHIP**

To provide the ongoing opportunity for a Xaverian Brothers education and to honor Brother Richard Angarola, C.F.X., Dr. Stephen Savage '73 and Dr. Rebecca Booth have established this need-based fund to assist those St. X students proving high financial need while maintaining a commitment to their academics and service to others. Students must also qualify under the Saint Xavier High School need-based financial assistance program to be eligible.

#### **THE DR. FRANCISCO J. BAJANDAS '61 MEMORIAL ENDOWMENT**

The Bajandas Endowment was established in the summer of 2010 by the Bajandas Family to recognize the unparalleled education offered by Saint Xavier and to honor Dr. Bajandas for his commitment to Catholic Education. This fund provides support for those students and families demonstrating the greatest need for a tuition assistance award from the school.

#### **THE JERRY L. BARNES '63 AND FAMILY ENDOWMENT**

In loving memory of Cheryl Barnes, and in gratitude for the total education of mind, body, and spirit provided to Jerry Sr. '63, Jerry Jr. '83, Eric '86, Chris '87, and Aaron '01 by Saint Xavier High School, the Barnes Family established this endowment in the winter of 2014 to provide a need-based tuition assistance award. The family also has a strong belief that the maximum benefit of the Saint Xavier experience is derived from total family involvement. In support of these beliefs, preference will be given to students who maintain a strong academic record, participate in extracurricular activities, and whose parents or guardians participate actively in the Tiger Boosters. The Barnes Family's commitment to providing a St. X education to the young men of greater Louisville has been a long tradition. This fund will allow that practice to continue in perpetuity.

#### **NEW-THE CLETUS A. BECHT '39 ENDOWMENT**

Established in the spring of 2019 by Deborah K. and James H. Becht in loving memory of Cletus A. Becht, Class of 1939, this endowment will provide need-based financial assistance to qualified students, with first preference given to those living in the Highlands neighborhood and surrounding area. Cletus and his brothers benefited from a St. X education thanks to the sacrifices of their family. Similarly, this endowment will benefit families with a strong belief in and dedication to a quality Catholic education.

#### THE BENEKE FAMILY ENDOWMENT

This endowment was established in November of 2001 by The Beneke Family: J. David Beneke '52†, Peter '49†, Michael '90 and Stephen '87 to support Saint Xavier's need-based tuition grant program. Funds will be used to award tuition assistance in each academic year and have no other restriction.

#### DOMINIC JOSEPH BERGAMINI† ENDOWMENT

Frank '50 † and Peg Bergamini established this endowment fund in 1996, in memory of their grandson Dominic Joseph. Dominic, whose short life energized the St. X family, taught many how life should have such a special meaning to us all. This fund will provide tuition assistance to a young man who desires a Catholic education, but otherwise would not have the financial ability to do so.

#### THE BOLANDER SCIENCE ENDOWMENT

The Bolander Science Endowment will promote the study of top notch science at Saint Xavier High School, which was established and developed by the Xaverian Brothers. The fund will allow students with a passion for science and engineering (STEM) to discover that science teaches us how God created the universe and that engineering is employing that knowledge to help others. In the St. X environment, those with a strong interest in science can learn with and help those less interested which will assist each generation to grow stronger as a group. The science faculty will not only support and prepare students, but also encourage them to fully develop their skills and to "pay it forward" just as the Xaverian Brothers did with their students.

#### NEW-THE KENNETH J. BOLTON FAMILY ENDOWMENT

This endowment was established in the spring of 2018 by the Bolton and Belshoff alumni of Saint Xavier to help provide need-based financial assistance to qualified students, with first preference given to those living in the Germantown area and neighborhoods closest to St. X. May Kenny Bolton's dedication, sacrifice, and belief in a quality Catholic education, live forever through this endowment.

#### NEW-THE JOHN '49, CHARLIE '49 AND LOWELL '15 BROWN FAMILY ENDOWMENT

To serve as a constant reminder of the appreciation the Brown Family has for the financial aid program at Saint Xavier, this need-based scholarship was established in the summer of 2018. The family supports the mission of St. X and recognizes the impact on the family beginning with twin brothers attending the Broadway campus in the late 1940's and continuing with the most recently graduated Lowell Brown in 2015. Students are required to qualify under the Saint Xavier High School's need-based financial assistance program. Additionally, the student will be in a family where both parent are married, working, active practicing Catholics, and will be attending St. X from a current Archdiocese of Louisville parish school.

#### BROWN-FORMAN CORPORATION ENDOWMENT

This endowment was established in October of 1999 to provide tuition assistance for needy young men regardless of race, religion and nationality who desire a Catholic education at Saint Xavier. The student recipient of each year's grant will be chosen by Saint Xavier High School.

#### MARY CATHERINE DOYLE BROWN† SCHOLARSHIP ENDOWMENT

This endowment was established in the fall of 2002, through a gift from Mrs. Brown's son, Charles A. Brown, Jr. '58. The endowment will support Saint Xavier's need-based tuition assistance program. Funds will be used to award tuition grants each academic year.

#### THE HARRY AND MARY BUNDSCHU MEMORIAL AVIATION FUND

The endowment was established in the spring of 2000 by Lawrence M. Bundschu '66 and will be used to provide an introduction to the joys of flying, to cultivate an awareness of aviation as a potential career path and to instill a positive sense of self-esteem. Each year, Saint Xavier will invite students to submit a 500-word essay describing the student's interest in aviation to the Advancement Office. The winning entry(s) will have a cash payment made in their behalf to a local flight school. This award is not meant to be a "sightseeing" trip, but to give the student as much actual flying experience as possible.

#### THE BURKE FAMILY SCHOLARSHIP ENDOWMENT

In recognition for the ongoing educational excellence at Saint Xavier High School, The Burke Family, consisting of Al '68 and Mary Jo, Chris '98 and Sara, Paul '95 and Nicole and Erin and Chris '83 Klein, established this endowment fund to support the continued needs of the young men pursuing a St. X education. Funds will be used for those students proving financial need while maintaining their academic standing and commitment to Christian Service.

#### ARTHUR AND IRENE BURKEL SCHOLARSHIP

Nicholas (Class of 1961) and Robert (Class of 1957) Burckel established the Arthur and Irene Burckel Scholarship Fund to honor their parents by providing need-based financial assistance to the most needy young men attending Saint Xavier High School. Because of Arthur and Irene's commitment to education, the boys prospered at St. X and then won scholarships to college (Robert to Notre Dame and Nicholas to Georgetown). This scholarship has been established both to honor their parents who instilled in their children the value of education and to provide support for students in most need of financial assistance to complete their education at St. X.

#### AL '31† AND GUY, HONORARY '86† CAMPISANO ENDOWMENT

This endowment was established in 1996, by Guy, Jr. '74, Mark '80 and the Campisano family to honor Al '31 and Guy, Honorary '86. In the early years, the Campisano family endured many hardships which have built a strong foundation for keeping them always sensitive to the less fortunate and appreciative of their blessings. In recognition of these blessings and in special thanks for the values Saint Xavier taught the Campisano family, this fund will be used to create a need-based award. This award will afford young men, who might not otherwise have the resources to attend St. X, the opportunity to receive the same strong values which were instilled in the Campisano family.

#### THE JOHN PATRICK CASEY '71 MEMORIAL

The Casey fund was founded in June of 1990 in memory of Dr. John Patrick Casey, Class of 1971. Dr. Casey lived life to the fullest extent and was a true Christian example for all to follow. He embodied everything that we would expect of a student at Saint Xavier and today's students can aspire to fulfill the ideals for which he stood. The fund's purpose is to provide tuition assistance for the young men of Saint Xavier.

#### THE CLASS OF 1950 ENDOWMENT

This endowment was established in the fall of 1999, by the members of the Class of 1950 in celebration of their 50<sup>th</sup> anniversary since graduation. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. The endowment will provide a tuition grant for at least one Saint Xavier student each year. The student must demonstrate financial need, and will be awarded to any young man meeting the criteria, regardless of race, religion or nationality.

#### THE CLASS OF 1956 ENDOWMENT

The endowment was created to provide a need-based tuition grant for at least one Saint Xavier student each year. This student must demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing. The award will be made to any young man meeting the criteria, regardless of race, religion or nationality. Saint Xavier will select the student based on the above criteria.

#### THE CLASS OF 1962 ENDOWMENT

This endowment, established by members of the Class of 1962, is in celebration of their 50<sup>th</sup> anniversary since graduation. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. This endowment is being created to provide a tuition grant for at least one Saint Xavier student each year. This student must demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing. The award will be made to any young man meeting the criteria, regardless of race, religion or nationality. This endowment, established by the members of the Class of 1967, will be in celebration of their 50<sup>th</sup> anniversary since graduation. It is a reflection of the class' commitment to provide the St. X experience for generations to come. This endowment was created to provide a tuition grant for at least one Saint Xavier student each year. The student must demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing. The award will be made to any young man who meets these requirements, regardless of race, religion or nationality. Saint Xavier will select the student based on the above criteria.

#### THE CLASS OF 1971 ENDOWMENT

This endowment was established in 1996, by the Class of 1971 in honor of their 25<sup>th</sup> reunion and to recognize the educational opportunities given to them by Saint Xavier and the Xaverian Brothers. The fund will be used to underwrite tuition grants awarded to economically needy students enrolled at Saint Xavier.

#### THE CLASS OF 1973 ENDOWMENT

This endowment was established in the summer of 1999, by the members of the Class of 1973 in celebration of their 25<sup>th</sup> anniversary. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. The endowment will provide a tuition grant for at least one Saint Xavier student each year. This student must be a legacy of the Class of 1973 and demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing.

#### THE CLASS OF 1974 ENDOWMENT

This endowment was established by members of the Class of 1974 in the spring of 1999. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. The fund will be used to provide a tuition grant for at least one Saint Xavier student each year. The student must be a legacy of the Class of 1974 and demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing. The award will be made to any young man meeting the criteria, regardless of race, religion or nationality.

#### THE CLASS OF 1977 ENDOWMENT

This endowment was established in the summer of 2002 by the members of the Class of 1977. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. This endowment was created to provide a need-based tuition grant for at least one Saint Xavier student that demonstrates financial need each year. The award will be renewable as long as the student maintains his required academic standings. The award will be made to any young man meeting the criteria, regardless of race, religion or nationality. Saint Xavier will select the student based on the above criteria.

#### THE CLASS OF 1981 ENDOWMENT

This endowment, established in the summer of 2006 by the members of the Class of 1981, is in celebration of their 25<sup>th</sup> anniversary since graduation. It is a reflection of the class' commitment to provide the Saint Xavier experience for generations to come. This endowment was created to provide a tuition grant for at least one Saint Xavier student each year. The student must demonstrate financial need. The award will be renewable as long as the student maintains his required academic standing. The award will be made to any young man meeting the criteria, regardless of race, religion or nationality. Saint Xavier will select the student based on the above criteria.

#### THE CLASS OF 1982 MEMORIAL ENDOWMENT

**This endowment, established in the fall of 2002, was created to honor the deceased members of the class who lost their lives at an early age. Upon the 25<sup>th</sup> anniversary, class members expanded their efforts to increase the endowment which now funds need-based tuition grants to Saint Xavier students. Saint Xavier High School makes these grant awards on an annual basis.**

#### THE CLASS OF 1983 ENDOWMENT

**The Class of 1983 Endowment was established in the fall of 2009, by members of the class in recognition of the successful twenty-fifth anniversary class reunion. This endowment will give first preference to students attending Saint Xavier from The Nativity Academy of Louisville and provides support for the need-based tuition grants Nativity students are awarded by Saint Xavier's tuition assistance program. Each year, at least one Nativity student will be selected as a recipient and will be renewable as long as the student maintains his academic standing.**

#### THE COY FAMILY ENDOWMENT

This endowment, established in 1991, is designated to assist the school where its needs are greatest. The Coy family has created this fund with the intention of helping ensure a reasonable Saint Xavier tuition.

#### THE REVEREND JOHN D. DEATRICK ENDOWMENT

This endowment was established in the fall of 2006 to further support Saint Xavier's commitment to need-based financial aid. Many families continue to believe in Catholic Education and this endowment provides another avenue to fund those in the greatest need. Father John spent a number of years on the Saint Xavier staff and worked with many students and families with similar financial needs to those which this endowment will assist.

#### THE GEORGE DIEBOLD† SCHOLARSHIP

This fund was established in April of 1993, by family and friends to memorialize George, a member of the Class of 1995. George was a fine young man and a true example for other students to emulate. His life, lost tragically, will continue to be remembered with this annual tuition assistance award.

#### THE SAINT XAVIER HIGH SCHOOL BOARD OF DIRECTORS' ENDOWMENT

The Board Fund was created to provide for general expenses as approved by the Saint Xavier High School Board of Directors. It also underwrites several faculty awards of \$1,000 each given at the end of the school year.

#### THE GERARD J. DOUGHER, JR., M.D. '70† ENDOWMENT

This endowment was established in the fall of 2006 to further support Saint Xavier's commitment to need-based tuition assistance by Mary Dougher-Foster and to honor and memorialize her beloved husband, Gerry, a member of the Class of 1970. With this fund, future Saint Xavier students will be afforded the opportunity to attend and pursue their educational dreams similar to when Gerry was a student in the late 1960's. The endowment's income will be reserved for the neediest students qualifying for support under Saint Xavier's tuition assistance program guidelines.

#### THE DOUGHERTY FAMILY ENDOWMENT

This endowment was established in the summer of 2000, by the Dougherty Family in grateful recognition of Saint Xavier's commitment to need-based tuition assistance. Family members Brother Patrick '43†, John T. '44†, William '51, John T., Jr. '73 and Joseph '82 have directed the school to use the income for the neediest students qualifying for support from Saint Xavier's tuition assistance program.

#### THE BROTHER CORBY DUFFY, C.F.X. MEMORIAL ENDOWMENT

The fund was established in 1994 for the purpose of providing tuition assistance to students who qualify under Saint Xavier's tuition assistance program.

#### THE SUSAN DUNAGAN MEMORIAL SCHOLARSHIP ENDOWMENT

This endowment was established in the summer of 2001, by John and Marlene Bohn, to provide tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education at Saint Xavier High School.

#### THE DUNBAR FAMILY ENDOWMENT

The Dunbar Family Endowment was established in November of 1998, to provide support for needy young men, regardless of race, religion or nationality who desire a Catholic education at Saint Xavier High School. The student recipient of each year's grant will be chosen by a designated member of the Dunbar family from choices provided by Saint Xavier High School.

#### MR. † AND MRS. † THOMAS M. FILBURN '35 FUND

Mr. and Mrs. Filburn established the endowment fund in 1982 in memory of their son Greg. Its purpose is to furnish need-based tuition assistance to deserving students enrolled in the art program.

#### ROBERT J. FITZPATRICK '35 † SCHOLARSHIP FUND

This fund was established in 1995 by Robert J. Fitzpatrick, Class of 1935. Its purpose is to provide tuition assistance to a student who demonstrates need, has an interest in the field of accounting and maintains good academic standing. Special consideration will be given to students in advanced placement courses.

#### THE BROTHER LEROY FLYNN, C.F.X. † ENDOWMENT FUND

The Brother Leroy Flynn, C.F.X. Endowment was established in the spring of 1998. Brother Leroy taught Biology and Advanced Placement Biology at St. X for fourteen years. He had a tremendous impact on his students at St. X, many of whom became doctors. This endowment will provide tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education.

#### THE JOHN J. FRANCIS † ENDOWMENT FUND

This fund was established by the family in 1993, to honor Mr. Francis for his many years of encouragement and support for Catholic education. The fund will award a tuition grant to an incoming freshman with strong academic skills, a participant in athletics, and entering Saint Xavier from a Catholic grade school. In addition, the student will need to qualify for tuition assistance through Saint Xavier's tuition assistance program.

#### THE WAYNE A. GORNET '44 FAMILY SCHOLARSHIP ENDOWMENT

This endowment was established in 2013 by his wife, Margaret Gornet and his children, Susan, David '76, Tim '82 and Terry '87 in his memory. This endowment will provide need-based tuition assistance to a student who may be interested in pursuing a career in engineering. The qualified recipients will be selected by school administration.

#### THE GRAESER ENDOWMENT

This endowment was established by Emil A. Graeser, II '48 and Nancy L. Graeser in the summer of 2000. The purpose of the fund is to provide for the long term financial needs of St. X. Funds may be applied toward tuition assistance (need-based) or as the school deems appropriate.

#### THE ROBERT "DOC" HAMILTON, HONORARY '00† ENDOWMENT

This endowment was established in the winter of 2000, in memory of Robert "Doc" Hamilton. Doc Hamilton was a member of the staff at St. X High School for twelve years. Not only did he take care of the athletes, but he also nursed any boy who got sick during the school day. His impact on the St. X community was, indeed, profound. This endowment was established to provide tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education at Saint Xavier High School.

#### THE MARSHALL W. HEAD '87 MEMORIAL ENDOWMENT

The Team Members of Modern Marketing established the Marshall Head Memorial Endowment in December, 2010 to honor Marshall for his significant contributions to Modern Marketing and for his example of integrity and faith to all who knew him. The fund provides support for those students and families demonstrating the greatest need for a tuition assistance award at Saint Xavier High School.

#### VERA HILL HECKMANN MEMORIAL SCHOLARSHIP

The Vera Heckmann Fund was founded in September of 1986. The fund was established to provide tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education.

#### THE MARY JANE AND JACK K. HELLMANN, M.D. MEMORIAL ENDOWMENT

The Hellmann Endowment was established in the fall of 2009 by Linda and David Hellmann '69 to honor David's parents Mary Jane and Jack. Dr. Hellmann was a staunch advocate of providing a quality education for his children, and Mrs. Hellmann believed that a Catholic education was the best option. This endowment provides need-based tuition assistance for students who are from an underrepresented minority.

#### RAYMOND J. HEMMERLE '34† ENDOWMENT

This endowment, through the estate of Mrs. Emma L. Hemmerle, was established in the summer of 2006. By honoring the wishes of her late husband, Raymond J. Hemmerle '34, this endowment bears his name and was created as a loving memorial to him. Mr. Hemmerle was a proud alumnus and wanted to ensure that a Xaverian Brothers education would continue to be available to those who desire one. The fund will be used to provide tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education.

#### CHARLES L. HIGGINS '48 ENDOWMENT

This fund, established by Chuck and Carmel Higgins in the fall of 1992, will be used to provide a tuition grant each year for a student who qualifies under the St. X tuition assistance program. In addition, preference will be given to students participating in the golf program or students

attending Saint Xavier from the Germantown area. There will be no exceptions in addition to those applied to all students.

#### THE JEROME J. HODAPP '35 MEMORIAL ENDOWMENT

Mary Hodapp established this endowment fund in February of 1996 in memory of her husband, Jerry, to assist Saint Xavier High School with its tuition grant program. This special fund will be used to provide tuition assistance to needy young men who desire a Catholic education at Saint Xavier.

#### THE JOAN M. HOGAN MEMORIAL SCHOLARSHIP

W. Glenn Hogan '81, in memory of his loving mother, Joan, established this endowed award in the spring of 2004. Mrs. Hogan had a great appreciation for Saint Xavier High School and did everything in her power to see that her son, Glenn, would have an opportunity to attend and graduate. This endowment, which represents "a gift for the mind" will provide need-based tuition assistance for those students showing the greatest economic need and greatest desire to attend Saint Xavier. The award is open to students of any race, religion or nationality.

#### THE HUBBS FAMILY ENDOWMENT

This endowed fund was originally established by Gerald Hubbs, Class of 1959, and later expanded by members of the Hubbs family, in recognition of their belief that a very real need exists for tuition assistance support to students attending Saint Xavier. The endowment benefits students who desire a Catholic education and qualify for a need-based grant through Saint Xavier's tuition assistance program.

#### CORNELIUS E. HUBBUCH, SR., HONORARY '77† ENDOWMENT

Cornelius E. Hubbuch was a long time board member and supporter of Catholic education as provided by the Xaverian Brothers at St. X. This endowment was funded in 1995, through two trust agreements established by Mr. Hubbuch. His long time goal at St. X was to encourage alumni and friends to be generous to St. X and, more importantly, sponsor the many tuition assistance needs of today's students.

#### THE GAIL AND TIM '61 HUGHES SCHOLARSHIP ENDOWMENT

The Hughes Family established this endowment in the fall of 2012, in recognition of Saint Xavier's consistent record of developing students with strong academic achievement. Each academic year, Saint Xavier High School will provide at least one need-based, tuition assistance award to a St. X student with an outstanding academic record. The Hughes Family has always been committed strongly to human services organizations through their volunteer service work and will give first preference to students who demonstrate a similar enthusiasm to their service hours while at Saint Xavier.

#### JOHNNY HUGHES MEMORIAL FUND

The Hughes Fund was established in December of 1983 to provide need-based tuition assistance for needy young men, regardless of race, religion or nationality, who desire a Catholic education.

#### THE JONES FAMILY ENDOWMENT

The Jones Family Endowment, Robert, Sr. '44, Robert, Jr. '76, Boland '78 and Michael '82, was established in the spring of 1997 by the family. The endowment will support Saint Xavier's need-based tuition grant program. Funds will be used to award tuition assistance in each academic year.

#### THE WILLIAM P. KELLY†, CLASS OF 1910 AND JOSEPH R. KELLY†, CLASS OF 1908 ENDOWMENT

The Kelly Family Endowment was established in the fall of 2005, by William P. Kelly, Jr., Class of 1947. Mr. Kelly wished to honor his father, William, and his uncle, Joseph, for their long standing commitment to Catholic education and to show great appreciation for the Xaverian Brothers. Today, an annual need-based award is presented to a promising young man desiring a Saint Xavier education and who can demonstrate a very real need for financial assistance.

#### THE KING ENDOWMENT

This endowment was established in the winter of 1997 by Beverly† and Patrick '48 King in grateful recognition of the Xaverian Brothers and the living endowment that they provided to Saint Xavier for so many years. Recognizing St. X's commitment to need-based tuition assistance, this fund will direct its income for the neediest students qualifying for support from Saint Xavier's tuition assistance program.

#### THE KLEIN FAMILY FUND

The fund was established in the winter of 1997 to provide need-based financial assistance to Saint Xavier students with diverse backgrounds. First preference will be given to an African American student with the greatest financial need. The Klein Family, Frank '65 † and Donna believe strongly that a Xaverian Brothers education should be available to those who desire one.

#### NEW-THE KRAMER FAMILY SCHOLARSHIP

To serve as a tribute for members of the Kramer Family and to assist students proving great financial need while maintaining a strong commitment to academic achievements, this memorial scholarship was established in the summer of 2017. Specifically, this endowment has been established in memory of Raymond George Kramer, Sr. and Benjamin Alan Kramer. Students are required to qualify under the Saint Xavier High School need-based financial assistance program.

#### THE JOSEPH L. LENIHAN '38 MEMORIAL SCHOLARSHIP ENDOWMENT

This endowment was established in November of 1999, to provide support for tuition assistance for worthy students who are financially needy, regardless of race, religion and nationality, who desire a Catholic education at Saint Xavier. The student of each year's grant will be chosen by Saint Xavier High School.

#### THE JOSHUA R. LOEB '92 ENDOWMENT

This endowment in honor of Brother Edward Driscoll, C.F.X. was established in 1992, by Josh Loeb, Class of 1992, and his family. The purpose of the earnings each year will be to enhance the abilities of Saint Xavier faculty members in the area of students with learning differences. The endowment's interest will be made available to faculty members involved with the "Excel Program." As more interest becomes available, it will be the goal of the endowment to enhance the abilities of all faculty members in the area of recognizing students with learning differences and working with these students to ensure a quality education during their four years at Saint Xavier.

#### THE DR. ALBERT† AND NORMA LUCKETT ENDOWMENT

This endowment was established in the fall of 2000 by Matthew J. Lockett '90 in honor of his parents, Dr. Albert and Norma Lockett, to support Saint Xavier's need-based tuition assistance program. Funds will be used to award tuition grants each academic year and have no other restrictions.

#### THE WILLIAM R. MAPOTHER, SR. '56 MEMORIAL SCHOLARSHIP ENDOWMENT

This endowment was established in the spring of 2007 by the friends and family of William R. Mapother, Sr. '56 to provide need-based tuition assistance for a student beginning his sophomore year. To qualify, students must have a strong commitment to the academic program, maintain at least a 3.0 GPA with a proven commitment to academic excellence and display involvement in extracurricular activities. Preference will be given to minority students with first consideration for African-American students. Recognizing Saint Xavier's commitment to need-based tuition assistance, this fund will direct its income to the neediest students qualifying for this particular fund's interests.

#### COACH JOSEPH F. MAUPIN, SR. '49 ENDOWMENT

This endowment was established in the fall of 2002 to honor Joseph F. Maupin, Sr., Class of 1949, a longtime grade school football coach and eight-time Toy Bowl winner. In addition, Coach Maupin spent two tours as a part of the Saint Xavier football coaching staff. The endowment will support Saint Xavier's faculty recognition program. Funds will be used to award an unrestricted cash stipend for one Saint Xavier coach each academic year.

#### THE MAZZOLI FAMILY ENDOWMENT

This endowment was established in 2013 by the Honorable Romano L. Mazzoli '50 in honor of his beloved late wife, life-partner and best friend, Helen Dillon Mazzoli. This endowment is also in honor of his devoted parents, Romano Mazzoli, who immigrated to Kentucky from Italy in 1914 and Mary Loppolo Mazzoli, also the daughter of Italian immigrants. Their dedicated sacrifices allowed him, his brother Richard '53 and sister Patricia Mazzoli Maloney, Presentation Academy Class of '55, to obtain Catholic educations. This endowment provides financial support for Saint Xavier's need-based Tuition Assistance Program which offers young men the opportunity to receive a Catholic education at Saint Xavier, which would otherwise be out of their reach.

#### NEW-The William S. "Bill" Meadows '89 Endowment

The fund was established by friends and family in 2016 to honor Bill Meadows. Bill was a loving husband, father, and friend, as well as a man of integrity and service to others. He worked hard. Bill never hesitated to lend a hand whenever there was a need. He learned the basis of these values during his days at Saint Xavier. To honor Bill's spirit, the award will be provided each year to a student who demonstrates a need for tuition assistance and is in good academic standing with evidence of Christian service to others. Preference will be given to a student meeting the aforementioned qualifications that has had a parent pass away either before or during his time at Saint Xavier.

#### THE THOMAS†, MILDRED† AND THADDEUS '99 † MEAGHER FAMILY ENDOWMENT

To recognize the commitment to Catholic education by Thomas and Mildred Meagher, the Meagher family established this endowment in the fall of 2003. The purpose is to ensure that young men will have the opportunity to attend Saint Xavier, similar to the Meagher children and their opportunity to receive a Catholic secondary school education.

#### JOHN MEIHAUS† SCHOLARSHIP ENDOWMENT

The endowment was established by Meihaus-coached athletes in June of 1994 in honor of Coach John Meihaus. This fund will permanently enable a person or persons to attend St. X who otherwise would not have the financial ability to do so.

#### The Cyril F. Meyer, Jr. '74 Memorial Scholarship

In recognition of their longtime family commitment to Catholic education and in appreciation for the Xaverian Charism that continues to demonstrate excellence for the young men of St. X, The Meyer Family establishes this memorial fund. The family values greatly a St. X education and hopes this will continue a young man's journey toward his personal goals. First preference will be given to Catholic students coming to Saint Xavier High School from the Archdiocese of Louisville and must also qualify under the St. X need-based financial assistance program to be eligible.

#### THE MILES FAMILY ENDOWMENT

This endowment was established to honor three long time benefactors of Saint Xavier High School, Harry E. Miles '20†, Curtis W. Miles† (Saint Xavier's Primary School 1911) and Herman R. Miles '32†. This endowment will support Saint Xavier's need-based tuition grant program. Each year, at least one student will be selected as a recipient of this award. The award opportunity is renewable and open to students of any race, religion or nationality.

#### HERMAN R. MILES '32† FUND

The endowment fund was established in June of 1991 to reward a Saint Xavier faculty member for outstanding teaching and community service. The recipient will be chosen each year by the faculty awards committee and will receive an engraved plaque and \$1,000 as a reward for exceptional work with the students and the school.

#### THE RICHARD MILLER ENDOWMENT

The Richard Miller Endowment honors the legacy of Richard and Mary Jane Miller and their dedication to assisting young men who are part of the Saint Xavier wrestling program. It will support the program's general operations with first priority given to equipment needs.

#### THE ROBERT '35 AND ROBERTA MITCHELL ENDOWMENT

Mr. Mitchell was allowed to attend Saint Xavier High School through the loving assistance of Brother Benjamin Burke, C.F.X. This gave him a great appreciation for the Xaverian Brothers and the many blessings afforded to him as a student. This endowment provides need-based tuition assistance for young men attending Saint Xavier High School and is open to students of any race, religion or nationality. First preference will be given to students attending St. X from a single parent home.

#### THE BROTHER THOMAS MORE, C.F.X. † ENDOWMENT

The fund was established in June of 1994, on the Class of 1944's golden anniversary, to recognize, in a very special way, the educational opportunities its dear friend Brother Thomas More brought to the young men of the Louisville community. This very special endowment will be used to provide tuition assistance to economically needy students and their families.

#### THE NICKY MUDD '80 † ENDOWMENT

The Nicky Mudd '80 Memorial was established in December of 1998 by the Mudd Family. Its namesake's energy, drive, commitment and courage were an inspiration to all who knew him. This fund will be used to provide tuition assistance to a deserving young man who shares these qualities, in both athletic endeavors and in the "Excel Program" classroom. The recipient must also qualify under the Saint Xavier tuition assistance program.

#### NEW-THE JAMES S. MUELLER '68 † ENDOWMENT

This fund was established in the spring of 2018, as the result of a gift from the estate of James Mueller, Class of 1968. Jim was always a great advocate for Saint Xavier, a long-time member of the St. Francis Xavier Society, and a superb volunteer in the Lexington, Kentucky area. The fund will support the students with critical financial need and the aspiration to achieve excellence by earning a St. X education.

#### THE MUELLER FAMILY ENDOWMENT

The Mueller Family Endowment was created in honor of Eleanor and John '48 Mueller by their children in 2015 for the benefit of the young men receiving need-based tuition assistance at Saint Xavier High School. The Mueller children all benefited from strong family values and were afforded the opportunity to attend many outstanding Catholic schools making this fund a tribute to their parents.

#### THE JENNY AND TED NICHOLS SCHOLARSHIP

The Nichols Endowment was established in the fall of 2015 to honor Ted Nichols for his ongoing commitment to a quality Catholic education for his children and in grateful recognition of his unparalleled efforts on behalf of his employer McCormick Equipment Company. Students who

qualify under the Saint Xavier High School need-based financial assistance program will be the annual beneficiaries.

#### THE LLEWELLYN REISERT NUNNELLEY† ENDOWMENT

This endowment fund was established in January of 1996, by Llewellyn Reisert Nunnelley and her family to assist Saint Xavier High School with its ongoing tuition assistance program. The fund will be used to assist at least one worthy student qualifying for a tuition grant, maintaining a strong academic record, and upholding the Christian values of Saint Xavier.

#### THE LAWRENCE J. O'BRYAN '77 ENDOWMENT

This endowment was established in 2013 by Larry O'Bryan, Class of 1977, to provide tuition assistance to a young man desiring a Xaverian Brothers education. This award will be based on family need, but preference will be given to a student taking courses in journalism, broadcasting, communications or government so as to encourage exploration of a career in one of these fields.

#### CLIFFORD G. OHLMAN '35† SCHOLARSHIP

Jonathon D. Ohlman '71 established this endowment fund in 1987, to honor his father. An award is presented annually to a financially needy sophomore or junior who is interested in and enrolled in a science course, and is actively involved in two extracurricular activities of different kinds, i.e., athletics, sciences, arts or other.

#### MATTHEW BLAINE "MATT" PIERCE† ENDOWMENT

This fund was established by the Martin family in October of 1993, in memory of Matthew Blaine "Matt" Pierce. It will be used to provide a tuition grant each year for a student who qualifies under the Saint Xavier tuition assistance program. In addition, it will be awarded to a well-rounded student who is above average and is involved in either athletics or student government activities.

#### THE SUSAN T.† AND HAROLD E.† ROSENBERGER ENDOWMENT

This endowment was established in the winter of 2014 by the estate of Susan T. Rosenberger. The use of these funds is restricted to allow Saint Xavier High School to provide tuition assistance to young men desiring a Xaverian Brothers education.

#### THE LORRAINE AND RICHARD J. RUST, SR. MEMORIAL ENDOWMENT

The Rust children established the Rust Memorial Endowment in December of 2010 to honor their parents, Lorraine and Richard, Sr., for their lifelong example of faith and perseverance. The unique commitment to high quality Catholic education for their children and grandchildren was always in the forefront of family priorities. This fund provides support for those students and families demonstrating the greatest need for tuition assistance awarded at Saint Xavier High School.

#### THE RUTLEDGE FAMILY ENDOWMENT

Peter Rutledge and his sons, Thomas '82 and Timothy '83, and their families established this endowment in 2005, in memory of their aunt, Sister Annette Rutledge. This endowment shall be used to support Saint Xavier's need-based tuition assistance programs with preference to young men who have a family connection to St. Joseph's Orphanage-Children's Home, where Sister Annette served for forty years, or to other young men who have been placed with a family through foster care or adoption. Funds shall be used to award tuition grants each academic year, which will be chosen by Saint Xavier.

#### THE ST. XCELLENCE CAMPAIGN ENDOWMENT

This endowment was established in the fall of 1982, by benefactors and friends of Saint Xavier High School during the St. Xcellence Campaign. The funds will be used for tuition assistance.

#### THE JENNIFER ANNE ROBINSON SASS AND JOHN ROBERT SASS '83 MEMORIAL ENDOWMENT

This memorial endowment was established by the Kremer and Sass families to afford need-based assistance to the young men desiring a St. X education. Knowing that these tuition assistance awards would be made in Jennifer and Robert's memory, the recipients will be guided by their spirits each day.

#### THE JAMES W. † AND ETHEL B. SCOTT ENDOWMENT

The James W. and Ethel B. Scott Endowment was established in the summer of 2010 by the Scott family to recognize the sacrificial generosity of the Xaverian Brothers and their parents, James and Ethel Scott. This endowment provides support for students who desire a Catholic education and qualify for a need-based grant through Saint Xavier's tuition assistance program.

#### BROTHER BONAVENTURE SCULLY, C.F.X. ENDOWMENT FUND

This restricted endowment was originally established in 1980 by an anonymous donor for the purpose of funding special projects identified by Saint Xavier. In the spring of 1997, the endowment was renamed in honor of Brother Bonaventure Scully, C.F.X., a very special teacher in this donor's time at Saint Xavier. Since inception, the earnings have favored technology projects, including the purchase of a microbiology lab station in 1988. In 1991, Macintosh computers and computer-aided design software were purchased and served as the beginning equipment for today's CAD program, and in 1993, five IBM personal computers and appropriate software were purchased for use in the school's EXCEL academic program.

#### THE DANIEL B. SHERMAN '97 MEMORIAL ENDOWMENT

The Sherman Endowment was established in the spring of 1997 by the family and friends of Danny Sherman to continuously allow a student to attend Saint Xavier in his name. Danny's smile was infectious, he lived his life to the fullest and he loved his family and friends. St. X was instrumental in making him the man he was becoming. This fund hopes to provide growth opportunities to current students and support for the families demonstrating the greatest need for a tuition assistance award.

#### THE MICHAEL B. SILLIMAN '62† ENDOWMENT

The Silliman Endowment was established in the fall of 2000. The purpose of the endowment fund is to award a need-based tuition grant to a deserving student who is of high character, has high academic standards and holds a strong desire to excel, regardless of race, religion or nationality, but does not have the financial resources to afford the opportunities offered at Saint Xavier.

#### THE SMITH FAMILY ENDOWMENT

The Smith Family Endowment was established in the summer of 2009 by Sue and Kevin Smith to recognize the unique impact Saint Xavier has had on five generations of family members who have attended the school. This endowment provides support for need-based tuition assistance with first preference given to students attending Saint Xavier from The Nativity Academy, otherwise to minority students attending Saint Xavier.

#### THE ROBERT L. '38 AND RUTH P. STEINMETZ MEMORIAL ENDOWMENT

Established in the summer, 2015, by the estate of Ruth P. Steinmetz to establish an academic scholarship in memory of Robert, Class of 1938 and Ruth. This fund will be restricted to students demonstrating financial need and will follow the Saint Xavier guidelines for tuition assistance.

#### THE CHARLES L. THIEMANN '55 ENDOWMENT

The Thiemann Endowment was established in the fall of 2012 by Charles Thiemann, Class of 1955 in grateful recognition of his teachers, most of whom were Xaverian Brothers, and specifically Brother Bonaventure Scully, C.F.X., to provide need-based scholarship support to the neediest boys at Saint Xavier. Brother Bonaventure had a very significant impact on Mr. Thiemann along with the St. X program which helped launch a very successful career. This fund hopes to provide growth opportunities to current students and support for the families demonstrating the greatest need for a tuition assistance award.

#### NEW-THE STEVEN VANOVER '08 FOUNDATION ENDOWMENT

This endowment, in memory of Steven D. Vanover '08 and established by the Steven Vanover Foundation, an organization that funds rare cancer research and provides academic scholarships at several Louisville schools. The endowment will provide support for need-based tuition assistance to young men desiring a Xaverian Brothers education. Steven Vanover Foundation board members include Mike '81 and Brenda Vanover, Michael '06 and Bethany Vanover and the Kevin '82 and Carla Raque family.

This endowment was established in the fall of 2000 to support Saint Xavier's need-based tuition assistance program. Funds will be used to award tuition grants each academic year and have no other restrictions.

#### THE WOLFORD ENDOWMENT

The Wolford family established this endowment in 1996, as a formal tribute to the Xaverian Brothers and faculty members who were such an inspiration to their sons John '72, Tom '73 and Bobby'82. Each year a need-based award will be made to enable a current Saint Xavier student to have the experiences cherished by Mary and John Wolford.

#### THE X '43 ENDOWMENT

This endowment was established in 1996 by the Class of 1943 to recognize the level of education, religious training, discipline and positive outlook on life that young men receive while attending St. X. This fund will enable a young man or men to attend Saint Xavier who otherwise would not have the financial ability to do so.

#### THE X-MEN OF STOCK YARDS BANK ENDOWMENT
