Part 1 – General

1.01 WORK SCOPE

- A. Provide new pool lifts and install in complaints with all ADA Pool Lift Laws.

1.02 SCHEDULING

- A. The completion date for the project is **31 January 2013**.

Part 2 – Service

2.01 SERVICE SCOPE

- A. Install new ADA Compliant Pool Lifts at the following locations:
 - Athens High School
4333 John R Road
Troy, Michigan 48085

 - Troy High School
4777 Northfield Parkway
Troy, Michigan 48098
- B. Provide a detail list of the materials that will be required to complete this project.
- C. Repair any and all areas damaged during the installation of the lifts. Make sure to take every precaution to ensure that no humans or surrounding environment is harmed. Any damage to structures, floors, wall, etc will be repaired with like materials at the contractor's expense.
- D. All debris must be removed and the area cleaned up at the end of each work day.

2.02 MATERIALS

- A. See attached document for the Pro Pool-XR Pool Lift. **Note:** The District will except alternate pool lifts systems if they are equal to the specifications provided and are 100% in compliant with ADA laws and regulations.

Part 3 – Execution

3.01 INSPECTION

- A. All work will be performed to the satisfaction of the Executive Director – Kenneth D. Miller or his representative. If during any and/or all inspections the work is found to be unsatisfactory, the discrepancy noted will be corrected at the contractor's sole expense and at no cost to the Troy School District within 10 days from the date of notice. The decision of the Executive Director or his representative will be final.
- B. Once the project is completed the company rep will be required to walk the project with the Executive Director for final approval.

3.02 SAFETY GUIDELINES

- A. During normal school hours all workers will be require to check in with the main office before entering school district property.
- B. Must maintain a safety zone around areas being serviced at all times.
- C. You will be required to check with the Executive Director prior to the start of this project for approval to store or create a staging area for equipment, gang-boxes, trailers and materials.
- D. The contractor will be solely responsible and abide by all federal, state, and local laws pertaining to the safety of all employees and observers and will maintain workers compensation as required.

3.03 QUALITY ASSURANCE

- A. Work areas must be kept safe, clean and organized at all times.
- B. Contractor will be responsible for any and all damage caused during the removal, installation and/or staging process.
- C. Hours of work will require prior approval from the Executive Director and are based on the City of Troy local code guidelines. The contractor will also be required to adjust their work schedule so it does not interfere with school activities or events.

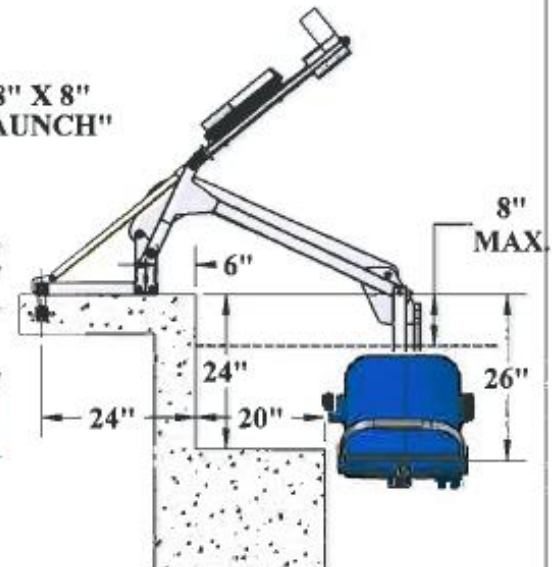
